
Office of Community Involvement





About the Office of Community Involvement

Created by a vote of the people in 1984, the Office of Community Involvement was established by County Charter to facilitate direct communication between the people of Multnomah County and the Board of County Commissioners. We are committed to helping inform and involve communities in the processes that shape county policies, budgets, and programs.

The office staffs the Community Involvement Committee, Multnomah County's advisory body on community engagement and involvement, and supports the Community Budget Advisory Committee program – groups of community members that review and make recommendations on county departmental budgets and operations.

Highlights from FY 2018-19

In the last fiscal year, the Office of Community Involvement worked with community members and County leadership to make updates to Multnomah County Code and the operations of the Community Involvement Committee, and developed new resources for supporting the County's advisory groups. A few highlights:

- Conducted a community survey and a series of five focus groups to collect input on how community members engage with Multnomah County, their experience with County community involvement programs, and their thoughts on the role and makeup of the Community Involvement Committee
- Convened a workgroup to review the sections of Multnomah County Code related to community involvement, and brought the workgroup's recommended changes to the Board of County Commissioners for their approval
- Made updates to our training materials for onboarding new Community Involvement Committee and Community Budget Advisory Committee members
