<p>Multnomah County Public Health will be analyzing and providing updates weekly.</p> <p>In December 2019, a respiratory virus identified as a novel coronavirus has spread from Wuhan, Hubei Province, China (population ~11 million) to other countries, including the US, through person-to-person transmission. Wuhan is a major air transportation hub in mainland China and infected travelers (mainly air) are known to be responsible for introductions of the virus in other cities. This incident was formally named COVID-19 by the World Health Organization in February.</p> <p>The first case reported in the United States was in Washington State on Jan. 21. Since then, a team of nurses and epidemiologists have been working full-time and on-call 24/7 to keep up-to-date on COVID-19. This team is trained to scale up quickly if needed. In addition, the team has established a response plan based on potential levels of risk to guide its actions.</p> <p>What we know about the novel coronavirus so far:</p> <ul style="list-style-type: none">• It is spread by close and prolonged contact with someone who is sick.• Reports so far suggest that the vast majority of people recover.• People with underlying medical conditions may be more likely to have severe illness.• There is no vaccine and no specific treatment. <p>Please review the Multnomah County Coronavirus FAQs and submit your questions if you can't find the answer. Operations

This is a dynamic situation. Information and case counts are changing rapidly and the incident is on-going.

WHO's situation report (2-25-20) reports 1,665 new COVID-19 cases in countries outside of China since the last Situation Report was distributed on February 17th. Eight countries have reported their first confirmed cases since that report. Published numbers from WHO include laboratory-confirmed cases and those reported as clinically diagnosed (currently only applicable to Hubei province, China).

United States

- People Under Investigation (PUI)** through 2/24/2020:
 - 14 confirmed cases
 - Arizona (1), California (8), Illinois (2), Massachusetts (1), Washington (1), and Wisconsin (1)
 - 412 negative tests

** Does not include PUIs in the US that were evacuated from the Diamond Princess cruise ship

As of February 23, 14 COVID-19 cases had been diagnosed in 6 states. Twelve of these 14

cases were related to travel to China, and two cases occurred through person-to-person transmission to close household contacts of a person with confirmed COVID-19.

An additional 39 cases were reported among repatriated U.S. citizens, residents, and their families returning from Hubei province, China (three), and from the Diamond Princess cruise ship that was docked in Yokohama, Japan (36). Thus, there have been 53 cases within the US. No deaths have been reported in the United States.

Health Department's Key Talking Points. Prepare, don't panic.

The risk to Oregonians is low.

- Right now there are no cases of COVID-19 in Oregon, but we know the risk is real.
- Local, state, and federal public health officials are working to detect any cases of this virus.
- If Oregon does get a case, public health officials have a plan in place to help the sick person and protect the public.

Don't discriminate

- We have heard reports of discrimination and stigma. We want to remind everyone that a person's ethnicity, language or association with a country is not a risk factor.
- Allowing misinformation to spread and ostracizing community members puts public health at risk.

What you can do now

- Wash your hands frequently with warm water and soap.
- Cover your mouth when you cough or sneeze, and stay home if you're sick.
- Keep your immune system strong by eating a healthy diet, getting enough sleep and regular exercise, and by taking care of underlying health conditions.
- Develop or update your household preparedness measures
 - Learn about your employer's sick and telecommuting policies.
 - Establish a childcare plan in the event your kids need to stay home from school.
 - Make sure you have the kinds of foods, drinks and medications you would want if you needed to stay home with a cold or flu for a couple weeks.
 - Get to know your neighbors, especially seniors, who might need support, especially if they live alone.
 - We do not recommend that people who are not sick wear masks.

- (**Facebook**): Multnomah County Health Department nurse Sara McCall fields calls from the public worried about #COVID2019. She is often asked, "I spent time with someone who may or may not be from China. Now I don't feel good. Am I at risk?"

"It's scary when people don't know. So it's our job to make sure people have the right information. The real risk here is travel, not ethnicity. It's travel," she said. "So making sure we understand that and people don't stigmatize people based on perceived county of origin."
