**Multnomah County Situation Report**

- **> Last week Multnomah County's facebook pages had 25,645 unique visitors.**
- **> The Mt. Scott Community Center opened as a homeless shelter with 60 beds. The shelter increases the total to 375 additional shelter beds across Multnomah County created to allow improved physical distancing for existing shelter guests. Guests are expected to begin arriving for dinner this evening.**

- ➤ In alignment with the [World Health Organization \(WHO\)](#), Multnomah County is moving toward the terminology: *Physical Distancing*. In addition to being a more accurate term, Physical Distancing also allows for the important focus on [social connection](#).
- ➤ Physical Distancing Shelters to reduce the capacity of existing shelters are currently serving 251 guests. Medical Motels - for shelter guests with undiagnosed respiratory ailments - are currently serving 57 guests.
- ➤ The National Weather Service (NWS) has created a [weather forecast page](#) exclusively for locations of temporary medical facilities to assist in planning.
- ➤ The [Oregon Department of Transportation \(ODOT\)](#) announced additional daytime closures of the Scenic Highway, due to continued traffic, beginning Wednesday at 8 am.
- ➤ Coordinating culturally-specific resources for domestic and sexual violence survivors, resources for child abuse survivors, and behavioral health resources.
- ➤ Monitored social media for trends, themes, concerns and misinformation in English, Spanish, Vietnamese, Russian, Vietnamese, and Chinese.
- ➤ Completed translations of CDC recommendations for use of cloth face coverings in Spanish, Chinese, Russian and Vietnamese.
- ➤ Monitoring community concerns from African-American and Black, Indigenous and People of Color (BIPOC) communities about risks to physical safety while wearing cloth face coverings or medical masks in public. Working with community liaisons and culturally-specific outreach teams to craft culturally-relevant public information.
- ➤ [1-page handout has been updated in 20-languages and English](#) to reflect current age-specific guidance on high-risk groups for those over 65.
- ➤ Video guidance for volunteers and neighbors to support vulnerable individuals staying at home (social connection, food/medicine/health care access) are available on Multnomah County social media pages -- [Facebook](#) and [Twitter](#).
- ➤ Prosper Portland's [Small Business Relief Fund](#) will open to loan applications on Wednesday, April 8 at 9:00 a.m. and close Saturday, April 11 at noon. Up to \$50,000 in zero-interest loans will be available for Portland businesses with \$5 million or less in annual gross revenue.
- ➤ A multidisciplinary team (Fire, Emergency Medical Services, Emergency Management, Human Services, Communicable Disease, and Behavioral Health) is being created to assist in prioritizing scarce resources. These disciplines are guided by an equity lens and prioritize requests based on public health guidance.

**Liaison updates**

**Liaisons** with subject-matter expertise have been identified to support community organizations, businesses, and agencies and are meeting weekly. Liaisons are listed below and are available to members of their respective sectors. Requests for additional sectors to be created that are not covered by the established liaisons can be sent to the Liaison Group Supervisor. **If you are interested in serving as a liaison, please contact the Liaison Unit Leader.** Please note that the cost for non-county staff interested and able to fill vacant roles will be the responsibility of their organization.

The liaison unit comprises 23 sector liaisons. These liaisons support community members by providing education and resources. They also listen to their members and elevate creative ideas and any questions to the EOC. Over 2,463 people participate in the liaison program and help spread accurate information throughout our community and beyond.

**Regularly Scheduled Calls:**

- Every Tuesday at 9am, the **Liaison Sector Leaders** have a meeting to share updates related to the EOC, public information, and activities.
- The **Culturally Specific Communities Liaisons** are holding a Communities of Color call on Thursdays 2-3pm.
- **Business Liaisons** participate on the FEMA Regional Grocer calls each Wednesday from 11am-Noon.
- The **School & Childcare Liaison** is holding daily 1pm calls with public K-12 school, a weekly call on Wednesdays at 11am with private K-12 schools, as well as communicating daily with child care providers through email.

**Business**

The Chair and Dr. Vines attended a virtual town hall for the business community, organized by PBA, on Monday 4/6/2020. The Chair delivered comments on Multnomah County's response to the COVID-19 pandemic, including steps taken to protect the shelter population and the people currently incarcerated in MultCo jails, and how the County fits into the response for the economic outfall from the COVID -19 crisis. Dr. Vines delivered comments on the public health response. Both the Chair and Dr. Vines answered questions, mostly revolving around budget implications of the former, and the duration of stay at home orders for the latter.
