

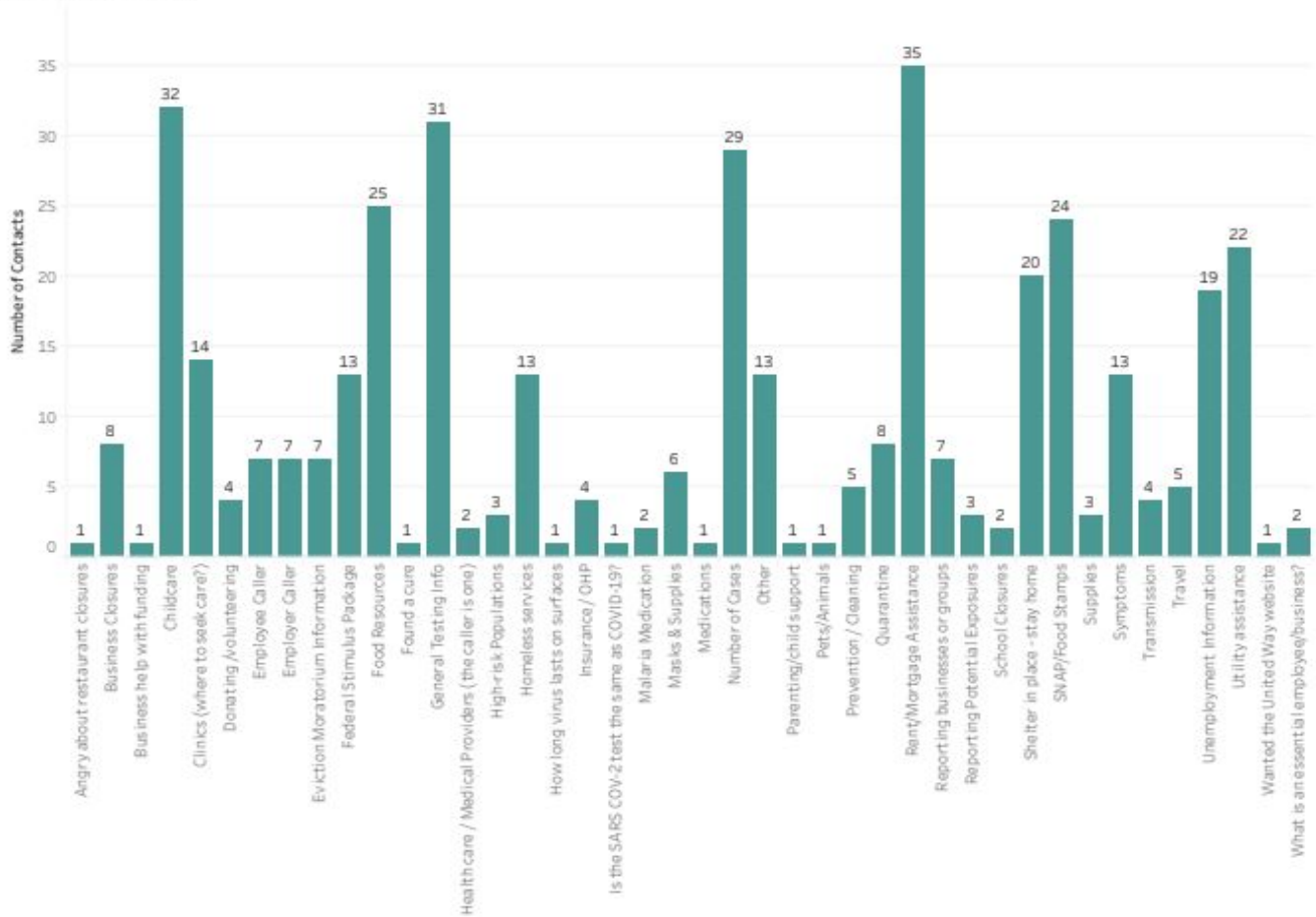

Medical Motels - for shelter guests with undiagnosed respiratory ailments - are currently serving 55 guests. ● > Today at 3 pm, Mayor Wheeler participated in a Twitter Q&A, giving Portlanders a virtual opportunity to interact with Mayor Wheeler and questions about the City's COVID-19 response.

- >Portland Parks and Recreation's Public Restroom Plan, of the 54 public restrooms to be open 24/7, more than 50% of those restrooms are now open with a goal to have the remainder open by April 10th.

- >Communicable Disease (CD) Investigations are ongoing, and team expansion continues.
- >The County call center received 6 calls and 7 emails. Increased number of general information calls and emails. There was also increased public interest in making donations.
- Prosper Portland's [Small Business Relief Fund](#) will open to loan applications on Wednesday, April 8 at 9:00 a.m. and close Saturday, April 11 at noon. Up to \$50,000 in zero-interest loans will be available for Portland businesses with \$5 million or less in annual gross revenue.

Liaison updates

Liaisons with subject-matter expertise have been identified to support community organizations, businesses, and agencies and are meeting weekly. Liaisons are listed below and are available to members of their respective sectors. Requests for additional sectors to be created that are not covered by the established liaisons can be sent to the Liaison Group Supervisor. **If you are interested in serving as a liaison, please contact the Liaison Unit Leader.** Please note that the cost for non-county staff interested and able to fill vacant roles will be the responsibility of their organization.

The liaison unit comprises 23 sector liaisons. These liaisons support community members by providing education and resources. They also listen to their members and elevate creative ideas and any

questions to the EOC. Over 2,463 people participate in the liaison program and help spread accurate information throughout our community and beyond.

Regularly Scheduled Calls:

- Every Tuesday at 9am, the **Liaison Sector Leaders** have a meeting to share updates related to the EOC, public information, and activities.
- The **Culturally Specific Communities Liaisons** are holding a Communities of Color call on Thursdays 2-3pm.
- **Business Liaisons** participate on the FEMA Regional Grocer calls each Wednesday from 11am-Noon.
- >The **School & Childcare Liaison** joins 1 pm calls on Tuesdays and Thursdays with public K-12 schools, hosts a weekly call on Wednesdays at 11 am with private K-12 schools, as well as communicating daily with child care providers through email and as needed with higher education.

Business

The Chair and Dr. Vines attended a virtual town hall for the business community, organized by PBA, on Monday 4/6/2020. The Chair delivered comments on Multnomah County's response to the COVID-19 pandemic, including steps taken to protect the shelter population and the people currently incarcerated in MultCo jails, and how the County fits into the response for the economic outfall from the COVID -19 crisis. Dr. Vines delivered comments on the public health response. Both the Chair and Dr. Vines answered questions, mostly revolving around budget implications of the former, and the duration of stay at home orders for the latter.
