Multnomah County Situation Report

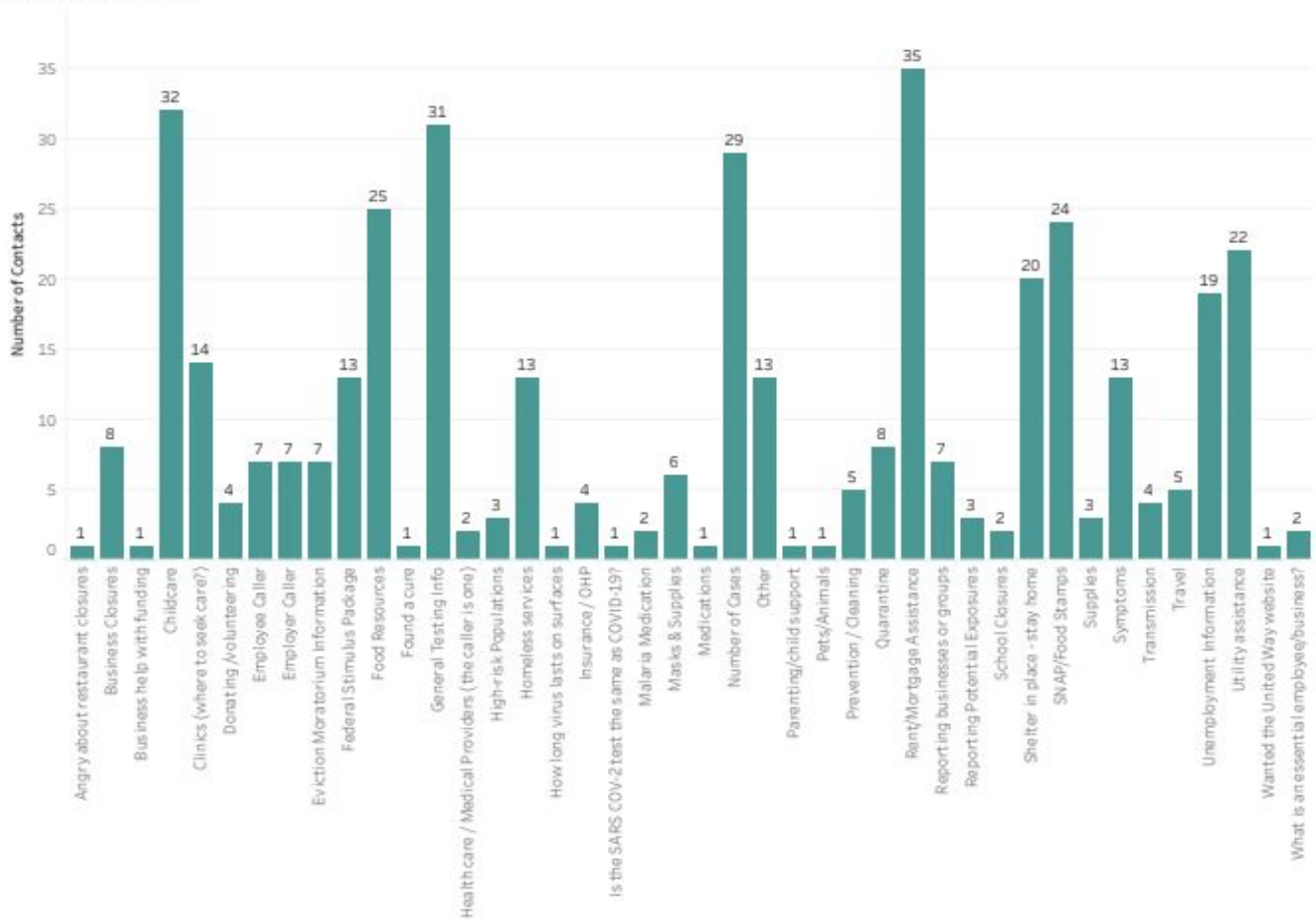
- **> Physical Distancing Shelters** to reduce the capacity of existing shelters are currently serving 242 guests. Medical Motels - for shelter guests with undiagnosed respiratory ailments - are currently serving 53 guests.
- **> Portland Public Schools** [paused their Chromebook](#) distribution today to allow the district to adjust the process to reduce wait times and acquire more devices.

- ➤ As of Thursday there were [146 current Coronavirus hospitalizations in Oregon](#), earlier this week OHA began releasing these numbers on a daily basis.
- ➤ The State of Oregon received 3 truckloads of PPE from Dubai. It is going to the State warehouse and will be distributed.
- ➤ Portland opens three outdoor homeless camps to try to contain the spread of coronavirus. ([Oregonlive](#)). **To reserve a spot, call 211; no walk-ups.**
- ➤ A bilingual mailer on COVID developed in partnership with Multnomah County and Portland neighborhood coalitions was released today. [Attachment to this report](#).
- ➤ The [Oregonian published instructions](#) on how to use the c19 symptom checker tool.
- ➤ Today it was released that Portland Police officers will [wear face coverings](#) such as cloth coverings, surgical masks, and respirators. Chief [Jami Resch acknowledges](#) it may feel strange for community members to wear a mask inside a business. Portland Police understands community concerns and knows the intent of wearing masks is to protect yourself and others. Portland Police continue to focus on illegal behavior, not face coverings.
- ➤ Communicable Disease Investigations are ongoing and team expansion continues.
- ➤ The County call center received 9 calls and 2 emails. There is an increase in the number of calls about testing.
- ➤ The Multnomah County Emergency Operations Center (EOC) is seeking volunteers who are interested in being reassigned to the EOC for a period of time, please [fill out this interest form](#). Filling out this form will not sign you up for a shift - once you fill out the form and get supervisor approval, someone will be contacting you to discuss possible positions within the Emergency Operations Center.
- ➤ Trimet [posted a video](#) with essential workers thanking operators who are working during this time.
- ➤ When getting outdoors this weekend, remember these tips to keep safe from COVID-19:
 - Stay close to home, except for essential trips.
 - Stick with your household contacts.
 - Keep at least 6 feet of physical distance from anyone who is not part of your household.
 - Wear a face covering or a mask when you cannot maintain 6 feet of physical distance - but know that a mask is not a free pass to socialize with people who are not household contacts.
- ➤ Due to [COVID-19 Multnomah County Vector Control](#) is not accepting insect samples from the public. Please use one of the identification resources for the website. You may email a picture to vector.nuisance@multco.us and we will try to identify it.
- ➤ The PIO staff reached out to Spanish language media to inform them of and confirm participation in the Latinx press conference on Monday

Liaison updates

Liaisons with subject-matter expertise have been identified to support community organizations, businesses, and agencies and are meeting weekly. Liaisons are listed below and are available to members of their respective sectors. Requests for additional sectors to be created that are not covered by the established liaisons can be sent to the Liaison Group Supervisor. **If you are interested in serving as a liaison, please contact the Liaison Unit Leader.** Please note that the cost for non-county staff interested and able to fill vacant roles will be the responsibility of their organization.

The liaison unit comprises 23 sector liaisons. These liaisons support community members by providing education and resources. They also listen to their members and elevate creative ideas and any questions to the EOC. Over 2,463 people participate in the liaison program and help spread accurate information throughout our community and beyond.

Regularly Scheduled Calls:

- Every Tuesday at 9am, the **Liaison Sector Leaders** have a meeting to share updates related to the EOC, public information, and activities.
- The **Culturally Specific Communities Liaisons** are holding a Communities of Color call on Thursdays 2-3pm.
- **Business Liaisons** participate on the FEMA Regional Grocer calls each Wednesday from 11am-Noon.
- The **School & Childcare Liaison** joins 1 pm calls on Tuesdays and Thursdays with public K-12 schools, hosts a weekly call on Wednesdays at 11 am with private K-12 schools, as well as communicating daily with child care providers through email and as needed with higher education.

Business

The Chair and Dr. Vines attended a virtual town hall for the business community, organized by PBA, on Monday 4/6/2020. The Chair delivered comments on Multnomah County's response to the COVID-19 pandemic, including steps taken to protect the shelter population and the people currently incarcerated in MultCo jails, and how the County fits into the response for the economic outfall from the COVID -19 crisis. Dr. Vines delivered comments on the public health response. Both the Chair and Dr. Vines answered questions, mostly revolving around budget implications of the former, and the duration of stay at home orders for the latter.
