<ul style="list-style-type: none"> <li>● <b>&gt; Physical Distancing Shelters to reduce the capacity of existing shelters are currently serving 193 guests. Medical Motels - for shelter guests with undiagnosed respiratory ailments - are currently serving 44 guests.</b></li> </ul>	

- >Physical Distancing Shelters and Medical Motels served guests a total of 6,719 meals between March 19th and March 30th. In the month of March, 149 loads of laundry were washed.
- >Multnomah County conducted a [press briefing](#) to highlight efforts to support Latinx communities, to offer recommendations for Latinx workers, and to answer questions for Spanish language media today.
- >The City of Portland will open three outdoor shelters to try to contain the spread of coronavirus. Those interested in a spot, can fill out an on-line form. For anyone without access to the internet, they can call 211. Forms:

- >Oregon Health Authority and State Department of Human Services are developing a guide that outlines their responsibilities related to Long Term Care Facility outbreak response.
- >The Multnomah County Board of Commissioners briefing on Tuesday, April 14 [will include a COVID update](#) from public safety and corrections health leaders.
- >An [air quality advisory](#) was issued earlier this morning (April 13) by the Department of Environmental Quality (DEQ) for the Portland metro area due to smoke from an industrial wood fire in Longview, Washington. DEQ's air monitor on Sauvie Island indicated unhealthy air quality. Monitors in north Portland and along the I-5 corridor showed moderate air quality. - >Mayor Wheeler and the City of Portland released a video on [distancing in the outdoors](#).
- >Analyzing local epidemiological data to identify disparities in rates of severe illness.
- >California, Oregon & Washington Announce [Western States Pact](#) to work on a shared strategy for reopening the three state economies.
- >Multnomah County's Rockwood Library is using its makerspace to produce Personal Protective Equipment. Library staff and youth mentors at the Rockwood Library makerspace are using the space's 3D printers and laser cutters to create face coverings for distribution. The printers are older and running at full capacity, but the team found an innovative way to increase production.
- Portland Public Schools will [resume a second round of device pickup](#) Monday, April 13 for students in need to complete their home-based distance learning.
- The Public Information Office has created a [Culturally-Specific Behavioral Health Resources](#) website page.
- The Multnomah County Emergency Operations Center (EOC) is seeking volunteers who are interested in working at the EOC for a period of time. If you are interested, please [fill out this interest form](#).

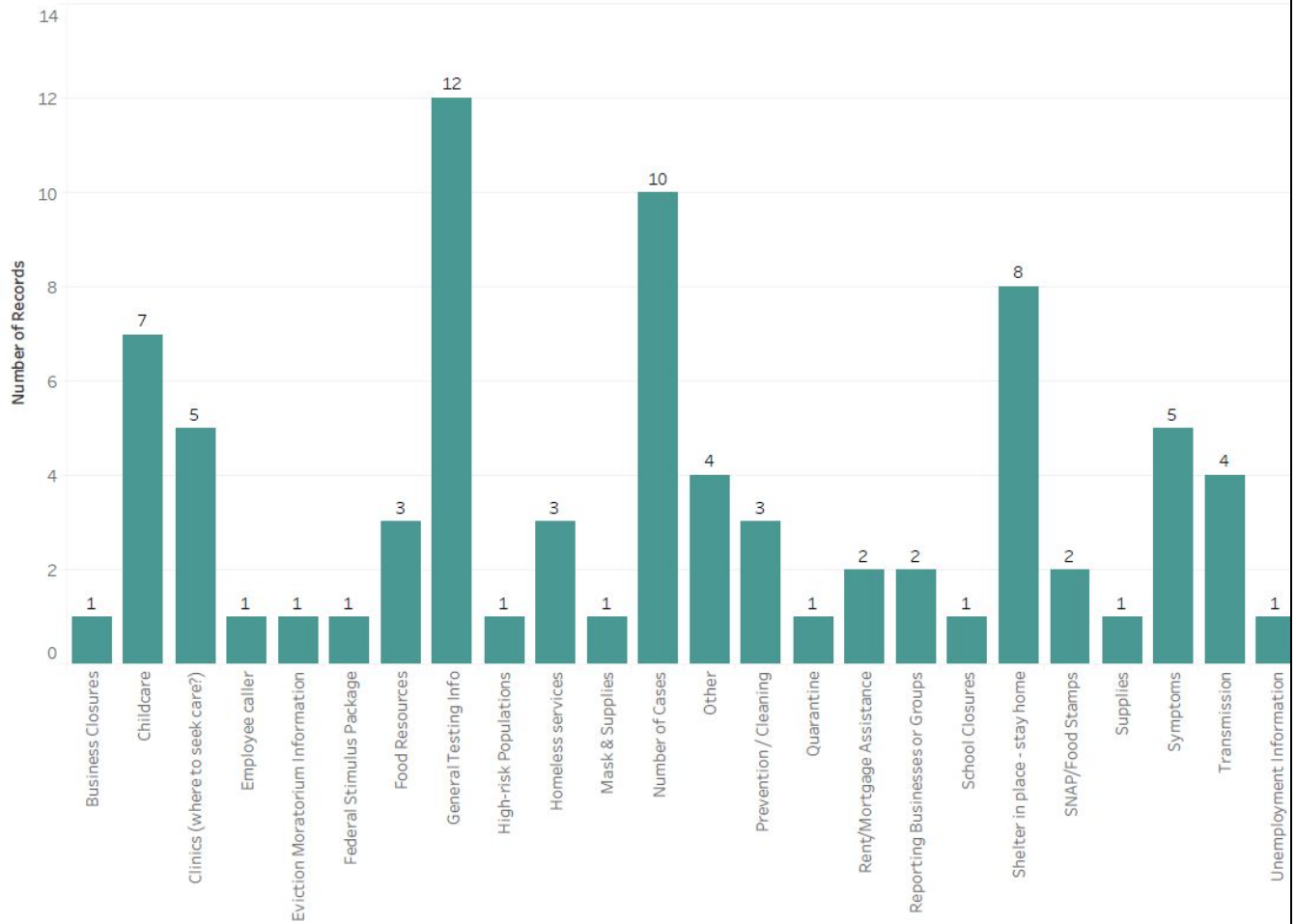
are experiencing worsening food or economic security due to COVID19-related job loss or school closures.

**Liaison updates**

**Liaisons** with subject-matter expertise have been identified to support community organizations, businesses, and agencies and are meeting weekly. Liaisons are listed below and are available to members of their respective sectors. Requests for additional sectors to be created that are not covered by the established liaisons can be sent to the Liaison Group Supervisor. **If you are interested in serving as a liaison, please contact the Liaison Unit Leader.** Please note that the cost for non-county staff interested and able to fill vacant roles will be the responsibility of their organization.

The liaison unit comprises 23 sector liaisons. These liaisons support community members by providing education and resources. They also listen to their members and elevate creative ideas and any questions to the EOC. Over 2,463 people participate in the liaison program and help spread accurate information throughout our community and beyond.

**Regularly Scheduled Calls:**

- Every Tuesday at 9am, the **Liaison Sector Leaders** have a meeting to share updates related to the EOC, public information, and activities.
- The **Culturally Specific Communities Liaisons** are holding a Communities of Color call on Thursdays 2-3pm.
- **Business Liaisons** participate on the FEMA Regional Grocer calls each Wednesday from 11am-Noon.
- The **School & Childcare Liaison** joins 1 pm calls on Tuesdays and Thursdays with public K-12 schools, hosts a weekly call on Wednesdays at 11 am with private K-12 schools, as well as communicating daily with child care providers through email and as needed with higher education.
