Multnomah County Situation Report


- ➤ Physical Distancing Shelters to reduce the capacity of existing shelters are currently serving 204 guests. Medical Motels - for shelter guests with undiagnosed respiratory ailments - are currently serving 31 guests.
- ➤ Oregon OSHA formally [begins spot-checks](#) in ramped up effort against COVID-19.

- > Multnomah County developed talking points based on the Governor's framework and Western States Pact. Note that these talking points are specific to Multnomah County, but can offer a starting point on aligned messaging across our region. [Attachment included with this report.](#)
- > The [Multnomah County Resource Request form](#) has changed in order to streamline requests and avoid delays in processing requests. Instead of emailing a form to the EOC, there is now a fillable Google form that must be submitted. For any questions about the process, there is also a dedicated email (eoc.rr@multco.us) and phone number (503-988-9840)
- Coordinated with Chair Kafoury's Office and the Library to translate documents into Spanish regarding Multnomah County's eviction moratorium.
- > Coordinating with many EOC and Multnomah County teams to organize a forum to support Black communities.
- > Updated community resources page with additional behavioral health resources to support Indigenous communities.
- > In the process of updating language pages to include video resources in American Sign Language.
- > Media monitoring in Spanish, Russian, Vietnamese, Chinese, and English.
- > Developing social media messages regarding underlying health conditions.
- > Over 6,900 views of the recorded press conference in Spanish with Multnomah County and OSHA to support Latinx and Spanish-speaking communities.

Liaison updates

Liaisons with subject-matter expertise have been identified to support community organizations, businesses, and agencies and are meeting weekly. Liaisons are listed below and are available to members of their respective sectors. Requests for additional sectors to be created that are not

covered by the established liaisons can be sent to the Liaison Group Supervisor. **If you are interested in serving as a liaison, please contact the Liaison Unit Leader.** Please note that the cost for non-county staff interested and able to fill vacant roles will be the responsibility of their organization.

The liaison unit comprises 23 sector liaisons. These liaisons support community members by providing education and resources. They also listen to their members and elevate creative ideas and any questions to the EOC. Over 6,597 people participate in the liaison program and help spread accurate information throughout our community and beyond.

Regularly Scheduled Calls:

- Every Tuesday at 9am, the **Liaison Sector Leaders** have a meeting to share updates related to the EOC, public information, and activities.
- The **Culturally Specific Communities Liaisons** are holding a Communities of Color call on Thursdays 2-3pm.
- **Business Liaisons** participate on the FEMA Regional Grocer calls each Wednesday from 11am-Noon.
- The **School & Childcare Liaison** joins 1 pm calls on Tuesdays and Thursdays with public K-12 schools, hosts a weekly call on Wednesdays at 11 am with private K-12 schools, as well as communicating daily with child care providers through email and as needed with higher education.

Aging & Disabilities, Veteran Services, Intellectual & Developmental Disabilities

- Facilitating weekly conference calls with community non-profits who are delivering services to older adults

Food and Hospitality Liaison Liaison

- Our liaison in conjunction with other County Health Inspectors has done outreach to more than 3,000 food and hospitality providers to discuss the latest updates about COVID-19.

Pharmacy Liaison

- Participating in weekly calls with state and pharmacy leadership.

Schools Liaison

- In light of the announcement that Oregon schools will be closed for the remainder of the school year, Oregon Department of Education released Graduation Pathways 2020 guidance in the [Distance Learning for All Guidance](#).

State

- ➤ As of Tuesday, April 14 there are 140 confirmed Coronavirus hospitalizations in Oregon, earlier this week OHA began releasing these numbers on a daily basis.

- Governor Brown released [a video](#) thanking public health workers at the end of the 25th annual Public Health Week. In the video, Governor Brown also thanks all Oregonians for following physical distance guidelines and urges continued observance as the weather gets nicer.

Federal/National

- ➤ New York governor Cuomo to issue an executive order requiring a mask or face covering in public. ([CNN](#))
- Maryland mandates face coverings in retail establishments and on public transportation. ([CNN](#))
- The CDC launched [COVIDView](#), a weekly report that summarizes and interprets key indicators from a number of existing surveillance systems.
- The Internal Revenue Service (IRS) payments to individuals have started to be issued. Most individuals who receive social security benefits, filed 2018 or 2019 federal income taxes, or receive Railroad Retirement benefits will automatically receive payments without taking additional steps. The IRS launched a new platform for people who do not normally file taxes to

be able to submit information so that they can get their benefit. To determine eligibility visit <https://www.irs.gov/coronavirus/economic-impact-payments>.

- In order to ensure the accuracy of the 2020 Census, the U.S Census Bureau has [announced](#) that it has requested an extension of the self-response period to October 31, 2020 and that Congress approve a 120 day extension to deliver final apportionment figures. The extension will allow for apportionment counts to be delivered to the President by April 30, 2021, and redistricting data to be delivered to the states no later than July 31, 2021.
