
# **Epidemiology Data**

This is a dynamic situation. Information and case counts are changing rapidly and the incident is ongoing.

COVID-19 cases and deaths in Multnomah County and in Oregon


There were **148 new confirmed and presumptive COVID-19 cases** reported in Oregon on June 18. **Thirty-three** of these new cases are in Multnomah County. Since the pandemic began, there have been a total of 1,665 confirmed and presumptive COVID-19 cases in Multnomah County and 6,366 cases in Oregon. Multnomah County cases make up 26% of the state's total. The chart below shows cases over the past week.

There were **four new COVID-19 deaths in Oregon** reported on June 18. **None** of these deaths were in Multnomah County. A total of 68 people are known to have died of COVID-19 in Multnomah County since the pandemic started, and there have been 187 known COVID-19 deaths in Oregon, statewide. Multnomah County deaths make up 36% of the state's total. The chart below shows deaths over the past week.


#### Race and Ethnicity Impact in Multnomah County

Detailed local data, including demographics (race, sex, age, and housing status) are available in the Regional COVID-19 data dashboard hosted by Multnomah County. The dashboard also contains data on case counts, hospitalizations, symptoms and coexisting conditions, and testing. For statewide data on COVID-19 cases in Oregon by sex, age group, race, and ethnicity, consult the Oregon Health Authority's Demographics and Disease Severity dashboard.

The charts below show the percentage of total cases, deaths, and hospitalizations by race and ethnicity (in gray), as of June 17, 2020. Each chart also shows the proportion of Multnomah County's total population by race/ethnicity (in orange). Instances where the percentage of cases, deaths, and hospitalizations exceeds the proportion of Multnomah County's total population by race/ethnicity indicate the communities that are most impacted by health inequity from COVID-19. These differences may reflect the inequitable distribution of the risks of being exposed to COVID-19 and the opportunities to access medical care and COVID-19 testing.

#### Cases by race/ethnicity and population proportions





#### Deaths by race/ethnicity and population proportions


Percent of COVID-19 Deaths Compared to Multnomah County Population Proportions

# Multnomah County Emergency Operations Center Updates

The Multnomah County Emergency Operations Center (EOC) is a temporary network that works within the Mission, Vision and Values of Multnomah County. The EOC develops objectives based on guidance from the Chair and Chief Operating Officer. The EOC provides wrap around services to support County departments that are operating beyond their normal capacity. The EOC provides a framework that incorporates staff from across all County departments, as well as community volunteers and representatives from partner agencies and organizations to direct the full complement of this combined effort toward accomplishing the County's objectives.


# EOC Section: Operations

The Operations section has several operational areas, each of which report on daily metrics. Weekly metrics are reported each Wednesday.

#### Resource Request Unit

The Resource Request Unit is a group of diverse subject matter experts that represent and advocate for the needs of the communities Multnomah County serves. The team allocates critical supplies and Personal Protective Equipment (PPE) to health and community organizations in order to prevent the spread of COVID-19. When allocating PPE, the Resource Request Unit prioritizes organizations experiencing an outbreak, organizations that perform life saving operations (hospitals, clinics, etc), and organizations that serve communities of color, people ages 65 and older, and people with underlying health conditions. These priorities are part of Multnomah County's commitment to dedicate resources to the populations most impacted by COVID-19.

<u>Daily Metrics:</u> The Resource Request Unit tracks how many requests for resources it processes over a 24-hour period ending at 12 pm each day. The chart below shows the number of daily requests processed over the past two weeks.





#### Call Center

The EOC Call Center answers COVID-19 questions and concerns from community members who call the Multnomah County Health Department, and occasionally in support of 211. They also help community members sign up for COVID-19 testing events.

<u>Daily Metrics</u>: The Call Center tracks how many calls and emails it responds to each day (the Call Center is open Monday through Friday). The chart below shows the number of calls and emails per day for the past two weeks, broken down by three topic categories.



# EOC Section: Mass Care and Shelter (Emergency Support Function 6)


Multnomah County operates three Physical Distancing Shelters and one Physical Distancing Motel, with a total capacity of **365** people; as well as two Isolation Support Motels with a total capacity of **120** people.

<u>Daily Metrics:</u> The Mass Care and Shelter Unit tracks how many people are housed in Physical Distancing Shelters and Motels, and in Isolation Support Motels each day. The charts below show the number of people housed for each day of the past two weeks.

## **EOC Section:** Logistics

The Logistics Section supports the response actions of all other EOC sections. Logistics focuses on procedures for activating, dispatching, distributing, allocating, tracking, and deactivating resources needed for emergency and disaster operations from government, private, or volunteer sources. For Multnomah County's COVID-19 response, important Logistics functions include coordinating the donation of supplies, delivering resources to community partners, and coordinating volunteers.

#### **Announcements**

• The Logistics Section completed a major step in demobilizing the East Portland Community Center Physical Distancing Congregate Shelter (EPCC) today. In the ten days since the last guest relocated from EPCC, eight members of the Logistics Section and four members of the Oregon Air National Guard relocated approximately six tons of equipment and supplies. As much as possible, materials were redistributed to Multnomah County shelters that are still in operation, or stored in County trailers to ensure response readiness for future events. Over the coming weeks, the County will complete mutually agreed upon repairs and cleaning before returning the facility to Portland Parks & Recreation.

#### **Donations Unit**


Multnomah County is seeking **home-made face covers** or **home-made cloth face coverings**, which should be unused and in good condition. Multnomah County's Operations team is dedicated to ensuring that these scarce resources are distributed to Black, Indigenous, and People of Color (BIPOC) communities. Across the country, these communities are statistically more likely to suffer grave outcomes of COVID-19 and are therefore, our donation priority. A multidisciplinary team is working with community organizations across the county to distribute these, and other supplies.



The Portland Street Response Team is seeking donations of the following items: tents, sleeping bags, warm blankets, tarps, ponchos, hand warmers, hygiene kits, backpacks, socks, bottled water, Emergent-C, and snack bars. These items can be dropped off Monday - Friday, 9 AM - 4 PM at Portland Street Response Team, located at Portland Fire and Rescue, 1300 SE Gideon St. Portland, Oregon 97202.

#### Resource Deliveries

Logistics provides transportation for numerous response functions, including delivering supplies to community partners. The chart below shows the number of daily trips delivering resources to community organizations, hospitals, County-run physical distancing shelters and medical motels, and emergency outdoor shelters run by the City of Portland and Multnomah County's Joint Office of Homeless Services. The chart does not represent the quantity of supplies included in these deliveries, so a single delivery could include small or large quantities of resources.



# EOC Section: Community Liaisons

Liaisons with subject-matter expertise have been identified to support community organizations, businesses, and agencies and are meeting weekly. Liaisons are listed below and are available to members of their respective sectors. Requests for additional sectors to be created that are not covered by the established liaisons can be sent to the Liaison Group Supervisor. Please note that the cost for non-County staff interested and able to fill vacant roles will be the responsibility of their organization.



#### Community Resource Distribution Project

Multnomah County is distributing bulk hand sanitizer and decertified KN95s (now considered face coverings) at no charge to small businesses, non-profits, and community groups that primarily serve communities of color, people with disabilities, elders, and families experiencing economic insecurity.

In the past two weeks, the County has distributed over 200,000 decertified KN95 face coverings and 1,000 gallons of hand sanitizer to community groups such as churches, childcares, physical distancing shelters, long term care facilities, substance abuse recovery businesses, culturally specific organizations,, community centers and many more.

If you represent a group that is able to distribute face coverings and hand sanitizer to groups that serve Black, Indigenous and People of Color, people in congregate or multi-generational settings, people age 65+, and people with underlying conditions, please <u>submit a request to Multnomah County</u>. Organizations that receive these items can not charge others for them. In addition, we ask that you follow these <u>guidelines for labeling</u>.


# Media and Announcements

# State of Oregon Updates

#### Media and Announcements

• On June 10, Oregon Driver & Motor Vehicle Services (DMV), extended the deadline for ID and vehicle registrations that couldn't be renewed due to the pandemic. They also negotiated a citation moratorium



- with Oregon's law enforcement agencies. The citation moratorium and license and registration deadlines are all extended to October 1. More details are at the DMV's <u>COVID-19 Update</u> page and in the DMV's memorandum about the deadline and moratorium extensions.
- On June 11, Governor Kate Brown's office released its <u>Equity Framework in COVID-19 Response and Recovery</u>, "a roadmap to support state agencies, boards, and commissions." More information is available <u>on the Governor's website</u>.
- On June 16, <u>Oregon Attorney General Ellen Rosenblum and 38 other state attorneys general sent a</u>
   <u>letter</u> to the chief executive officers of Google and Apple, to express their "strong concerns regarding
   the proliferation of contact tracing apps on your platforms that do not sufficiently protect consumers'

<sup>\*</sup>Every hospital in Oregon is asked to submit data twice daily to Oregon's Hospital Capacity Web System (HOSCAP). Data are based on the most recent report from the hospitals, available as of 9:00 a.m. Hospital staff are asked to enter bed capacity information, by type, as well as the number of patients with suspected or confirmed COVID-19 illness who are currently hospitalized at the time of data entry. These data may conflict with hospitalization status in Orpheus due to case reporting and investigation lags and temporary discrepancies in case classification.

# **National Updates**

#### Media and Announcements

- On June 10, the Occupational Safety and Health Administration <u>announced</u> a new <u>FAQ about wearing</u> <u>masks in the workplace</u>.
- On June 15, the <u>Food and Drug Administration revoked its Emergency Use Authorization</u>, which had temporarily allowed the drugs chloroquine and hydroxychloroquine to be used to treat certain hospitalized patients with COVID-19. This story was covered by the <u>Washington Post</u>.
- On June 15, the American Red Cross announced that it has begun testing all blood, platelet and
  plasma donations for COVID-19 antibodies. Blood donors will be informed of the result of the test on
  their donated blood. The Red Cross's <u>press release</u> notes that "A positive antibody test result does not
  confirm infection or immunity."
