| SUMMARY: Enacts Multnomah County ordinance establishing "Universal Preschool Program" providing two years of publicly funded, tuition-free, year-round preschool for age-eligible children in Multnomah County; eligibility not income based. First 12 to 18 months for planning, targeted implementation by 2022-2023 school year; countywide implementation by 2027-2028 school year. County may create administrative body or contract to administer program. Establishes requirements for providers to receive funding, including licensure, certification; programming options; mixed delivery model; staffing; wages (at least 145% of Portland minimum wage), benefits, professional development; union organizing code of conduct. Providers may charge for extended hours (in excess of six). Program funded by new tax on Multnomah County residents: 3.9% tax on taxable income under Oregon law (gross income minus deductions, other adjustments) over \$165,000 (individuals) and \$190,000 (joint filers). Requires dedicated fund for tax net revenue, including operations; reserve; planning, capital investment; and professional development subaccounts. Creates advisory committee of residents to make funding, other recommendations, evaluate effectiveness. County Auditor conducts annual financial audit, biennial performance audit.
