Emergency Operations Center

- Multnomah County is our local Public Health Authority
- Recognized the threat of COVID-19 early
- Activated Emergency Operations Center on January 30th





Regional Coordination

- Began coordinating early with Washington and Clackamas counties
- Convened regional health systems to establish a unified response strategy
- Established liaison programs with various public and private sector partners



Response to COVID-19// Supporting Homeless Neighbors

Supporting our Neighbors Experiencing Homelessness

- Certain populations, including those experiencing homelessness, are at a higher risk of contracting and spreading COVID-19
- Hundreds of county employees stepped up to help us meet new social distancing needs in shelters
- Entered into partnerships with local motels to provide isolation rooms for symptomatic individuals




Current Status of COVID-19 // Infections, Hospitalizations, Deaths

Current Status of COVID-19 *as of 7.29.20


Infections, Hospitalizations, and Deaths

COVID-19 hospital admissions by week





Percent of COVID-19 Cases Compared to Multhomah County Population Proportions



Current Status of Reopening

- Multnomah, Washington, and Clackamas counties have been grouped together for reopening
- Multnomah County has added additional benchmarks to ensure BIPOC communities are protected as we reopen
- Multnomah County is currently in phase I





Phase I Details:

- Face coverings required at all indoor public spaces, and whenever outside when 6 feet of distance cannot be maintained
- Restaurants, bars, personal care facilities, gyms, and fitness centers allowed to open up as long as they adhere to safety guidelines
- Local gatherings not including travel allowed, limited to 25 people
