If participant income is at 0.0%, they pay no monthly co-pay. They do, however, pay a one-time \$25.00 fee. The case manager bills them for the \$25.00; the participant mails a check for the \$25.00 to ADVSD. The one-time fee is NOT paid annually. Case manager does review financial eligibility annually. Invoice for the \$25.00 fee is posted on the provider page under CS Case Management.

If participant pays a monthly co-pay for OPI in-home services at any time during the year, the participant DOES NOT pay the \$25.00 one-time-only fee.
