Racial and Ethnic Approaches to Community Health (REACH) Presentation and Discussion	Approaches to Community Health (REACH) See attached slides for more detail REACH is a part of Chronic Disease Prevention and Health Promotion, which also consists of programs such as Tobacco and Violence Prevention Provide interventions at the large community level, really looking at upstream interventions and ways to reform the system Social and economic conditions, physical conditions and behavior account for 80% of health outcomes Community catalysts, making strong ties in the community REACH grant application was driven by community most impacted Really looking at how systemic racism has shaped policies, systems and environments and taking a comprehensive approach to address public health Lead explicitly with race but not exclusively Create culturally-specific strategies Community informed, meshed with public health strategies and community wisdom Black and Immigrant community continues to show up to protect health and welfare of community Neighborhood & Physical Environment Community and Social Context Education Economic Stability Health Care System Social determinants of health legislation being introduced at the federal level Need to continue funding at a local level Only 3% of money spent in health care is focused on preventative care The same risk and protective influences on violence intersect with chronic diseases Disparities between African American/Black adults compared to Whites is staggering Amount invested in health disparities is much smaller than cost of care REACH program strategy areas: Nutrition Healthy Nutrition Standards Breastfeeding Culturally specific CSA Don't provide direct services - work with community partners	Charlene McGee, Tameka Brazile

- Healthy nutrition standards

- Community Clinical Linkage
 - Connecting community to existing health resources
 - When community doesn't see points of access, they tend not to use it
 - Tobacco cessation doesn't resonate with community, so looking at different strategies

 - Ten leading causes of death connected to build environment
 - Traffic injury
 - Physical inactivity
 - Air pollution

 - National childhood obesity campaign
 - 5 or more fruits and veggies, 2 hours or less of screen time, 1 hour or more of physical activity, 0 sugary drinks more water

- Funding
 - Where can community members bring voice? If REACH funding is federal, what happens if it goes away someday? How can we ensure that this work continues forward?
 - o In year 3 of 5 of grant
 - In the coming year, we're going to be briefing the Board of Health on how addressing root causes helps across the board
 - Bringing awareness to the business sector about how public health impacts them directly and indirectly
 - Building capacity and support across the community
 - Opportunity with PH Modernization system
 - REACH is the cornerstone of modernized system
 - Will be opportunities for MCPHAB to voice support and talk about what modernization looks like in next rounds of Modernization funding
- SNAP-Ed program
 - Working with Farmer's markets to address barriers to accepting SNAP
 - Not only is it difficult to find one that accepts SNAP, but a lot of folks who are chronically ill and homebown are unable to wait in line to get stuff from farmer's markets. Curbside pickup options are extremely limited.
 - Some CSAs accept SNAP, but you have to find farms that accept it, which is difficult
- REACH partnered with CSA pickup
 - Shifted to home deliveries
 - Had to shift and pivot to make CSAs more accessible and remove barriers
 - o CSAs that REACH offers are fully funded by REACH
 - Partner with Black and African farmers to grow the food for CSAs
- Focusing on equity in the entire food process, including the production of food, is important
 - Thinking in terms of the farm workers themselves, shipping, etc
 - Thinking of the entire systems towards health
- In terms of having stores urban agriculture is not going to solve larger equity issues
 - Would it be possible to have food carts parked in neighborhoods to offer community-specific groceries?
 - We have those connections internally and it fits with Portland
- Beyond Black built a mobile food vehicle which sold fresh fruit and veggies prior to COVID
- RFP out for 2-acre property where REACH has partnered with office of sustainability
 - Looking at helping to grow and enhance food farmer to food institution
 - Identified a number of BIPOC farmers to do a food procurement process for Rockwood Rising space

	 Working on a short video of work we are doing with food system Debbie lead the work for having mobile food carts at clinics, called My Street Grocery 	
	 Contracted with farmers Was at 5 different Legacy sites Funding came from a grant - people were given vouchers for \$10-\$20 to spend on grocery items 	
Public Health Updates	 Patricia Charles-Heathers has decided to leave her position as Health Department Director Ebony Clarke, who has been the Behavioral Health Director, will be stepping into this role - will start 12/16 COVID-19 spread has been ramping up PCC and REACH opening next testing/vaccine site tomorrow (12/2) My vision is to keep supporting the work that you have already been doing - both/and conversation Have to continue to focus on COVID-19, but want continue the work on underlying conditions and long-term response and commitments - all of the work that you have already started All of this work is connected COVID is the overlay of a distraught situation We've seen response in the past get myopic (e.g. buy more PPE), but that's just a part of the response needed Challenge to tango and not wrestle with the system Moving things forward and working with elected officials is like a dance The window is wide open for making some long-term change 	Jessica Guernsey
Legislative Agenda	 Adelle gave an overview of the DRAFT Legislative Agenda See document for details Questions: What does Increase fairness through modernizing the property tax mean? Action Item: Adelle will follow up with Government Relations and circle back with MCPHAB The legislative agenda will be discussed at the 12/10 Board of Commissioners meeting Concerned on many levels - taxing those who are disenfranchised instead of looking at the whole system It is regressive to tax the consumer, who will be suffering the most We should not think about how to generate revenue from property tax, but how to disentangle property tax from education Make sure that every public school student has the same opportunity for education and that property taxes are not ensuring privilege Important to bring in what is already happening in the community on many levels Plan to invest in a system of healthcare that is not dependant on regressive taxes Modernizing tax system is more of what we can do locally Putting on my medical hat - attempting to limit tobacco products and alcohol consumption through taxation has been effective 	Adelle Adams
