Executive Summary

The Policy Director is the primary policy advisor to the District Attorney and is MCDA's lead on the formation and implementation of policy proposals as directed by the District Attorney. The position was created to effect policy reforms necessary to achieve a more equitable and just criminal justice system. The Policy Director performs the research, analysis and community engagement necessary to assist the District Attorney with reassessing core operations. The Policy Director is the primary ambassador to the community on matters of policy change and development, and will actively interface with diverse stakeholders to provide input throughout the policy development process. The Policy Director also works with legislators, serves on legislative workgroups and otherwise acts as the primary representative of MCDA at the legislature.

Program Summary

MCDA is engaging in a critical reimagining of the role of the prosecutor in a criminal justice system that is all too often characterized by racial, ethnic and socioeconomic disparities. This critical reimagining needs to be comprehensive in scope. taking in the relationship between the prosecutor and broader law enforcement, existing charging and sentencing decisions, the use of pretrial and cash bail detention, and much more. This effort cannot be effectively made without dedicated staff. The Policy Director provides MCDA capacity to perform the research, analysis and community engagement necessary to assist the District Attorney to reassess core operations.

The Policy Director provides the larger community with a direct point of contact for the process of policy development. The Policy Director facilitates the formation and staffing of workgroups, listening sessions, and other opportunities to enable diverse stakeholders to have direct, meaningful participation in policies developed by MCDA. No other position at MCDA provides a comparable mechanism or point of contact for engaging with diverse communities. The disparities within the criminal justice system underscore the importance of providing community stakeholders with a dedicated point of contact who is not acting as a prosecutor, does not carry a caseload, and is specifically tasked with responding promptly.

The Policy Director provides expert guidance to other departments, outside agencies and the public and will represent MCDA to the public, elected officials, other agencies, governments and organizations. Responsibilities include, but are not limited to, making presentations, offering testimony, conducting community outreach, serving on external policy workgroups and task forces, and responding and resolving sensitive inquiries.

The Policy Director is the chair of a newly created internal policy development committee, which provides MCDA prosecutors with a greatly expanded ability to direct the development of policies which impact their work environment and professional quality of life.
