Project Title and Brief Description: Add new site: Reynolds High School Student Health Center

HRSA requires a new CHCB approval of the addition of the student health center at Reynolds to our FQHC Scope.

#### Describe the current situation:

The Board previously approved addition of the site to our Scope, and HRSA processed their approval as well. However, delays opening the site due to the COVID-19 pandemic now necessitate new documentation of Board approval, as HRSA's 6 month maximum on documentation has lapsed. The project has not changed in any material way since the Board approved the addition.

Why is this project, process, system being implemented now?

Approval is required by HRSA in order to include the site in the scope of the FQHC.

Briefly describe the history of the project so far (be sure to note any actions taken to address diverse client needs and cultures; to ensure fair representation in review and planning):

Over the last several years, the SHC program has worked to create equitable, sustainable and operationally efficient services that maximize health impact for children and youth in Multnomah County. This process has included conducting an assessment to better understand need throughout the County, and planning for SHCs in the high need areas of Reynolds School District. The resulted in opening a new SHC at Reynolds in January 2021. The Board was kept informed at all stages of planning, and previously voted to approve addition of the site to the FQHC Scope.

List any limits or parameters for the Council's scope of influence and decision-making: Any changes in services and sites must also be approved by HRSA through a detailed change in scope process that HRSA manages. All entities previously gave their approval.



Briefly describe the outcome of a "YES" vote by the Council (be sure to also note any financial outcomes):

- A yes vote confirms that the CHCB approves changing the FQHC scope of services, adding Reynolds as a site.
- Students at Reynolds would be able to access health services at a Multnomah County Health Clinic in their school.

Briefly describe the outcome of a "NO" vote or inaction by the Council (be sure to also note any financial outcomes):

A no vote would impede the ability of clients of the new health center to access affordable, comprehensive care, and the site's financial sustainability would be at risk.

#### What have been the recommendations so far?

The CHCB, County Commissioners, and School District have previously recommended and approved the new site and add it to the FQHC scope.

## How was this material, project, process, or system selected from all the possible options?

- A review of various reports demonstrating SHC performance trends, SHC management discussions, ICS leadership discussions, and Reynolds and Gresham Barlow SHC planning steering committee meetings and final reports.
- The high need for services in RSD was documented in several reports. The Medicaid Claim Analysis Report showed that RSD and David Douglas School District have the highest concentration of Medicaid insured school aged members and yet, RSD has no SHC.
