After someone die, the body is taken to a mortuary to wash the body and then taken to a cemetery to be prayed on and to be buried. Sometimes body washing and the prayers take place in the mosques for conveniences.

1. ***Please provide an explanation of what improvements are proposed to be completed in each phase and how and when you plan to implement each Phase.***


These Phases are simply the order in which we will utilize the site for burials. Phasing is intended to provide a general plan for development to assure a one to two-year inventory of available burial plots at all times, and allow the cost of development in manageable increments. Future phases will be maintained in a more natural character, while developed phases will have lawns and paths that are appropriately manicured.

2. We will not be developing any building at this point and there will be no drainfields.

1. Headstones are "flush markers", which are granite slabs that are slightly recessed into the ground in a horizontal orientation. This facilitates mowing and other maintenance of the lawn.




4 TYPICAL GRAVESTONE

3. **State of Oregon Requirements for Cemeteries:** Oregon Mortuary and Cemetery Board (OMCB) investigator Marianne Itkin emailed Land use planner Chris Liu saying "Although no application for licensure of a cemetery has been received by the Oregon Mortuary and Cemetery Board (OMCB), there is nothing in the general plans explained by Mr. Shishir that would prevent the Board from licensing the cemetery". Therefore, the board does not have any concern regarding the general plan of the cemetery.
