



## Background

In 2021 the Oregon Legislature passed **Senate Bill 710**. This bill changed how **restraints** and **involuntary seclusion** can be used in licensed Child Caring Agencies, like the Multnomah County's Juvenile Services Division A&E Program.

All youth served in a licensed Child Caring Agency must receive information about this bill. What you need to know about restraints and seclusions:

- **Restraint** means holding a child in a way that does not allow them to move.
- **Seclusion** means a child is locked in an area or room and is not allowed to leave.
