REVIEW AND APPROVE APRIL 2017 MEETING MINUTES

 Minutes from April's meeting were approved unanimously with the exception of Danny abstaining, and Bradford and David were not present to vote.

INTRODUCTIONS, ANNOUNCEMENTS

- ACSI members are encouraged to present on their professional work to the group.
- **ACSI subcommittees** (Air Quality and Energy & Climate) will have recurring meetings on a regular basis. Staff will provide agendas, meeting logistics, and help provide content.
- Hayden Miller shared:
 - The budget process concluded in May.
 - The 100% Renewables Resolution passed, which commits Multhomah County to 100% renewable electricity by 2035 and 100% renewable energy by 2050.
 - As a result of the legislature not funding Cleaner Air Oregon, Commissioner Vega Pederson is excited to support a study conducted by Good Company, regarding the feasibility of a local air district.



- The Board is beginning to look into legal options on reducing diesel, within our jurisdiction.
- John Wasiutynski shared:
 - Multnomah County is considering if the Home Energy Scores program, which passed in the City of Portland, can be implemented throughout Multnomah County.
 - He introduced Pathways to 100, a series of discussions held with PGE, NW Natural, and the City of Portland about the transition to 100% renewables.
 - T21 passed in Oregon, where tobacco cannot be purchased by people under the age of 21.
- **Mary Peveto** shared that Metro Council will have a hearing on their waste to energy proposal on 7/25/17, which is the proposal regarding burning waste near Salem, in effort to divert 12% of total waste typically going to landfills.
- Jae Douglas shared that the County is moving forward to pass the woodsmoke ordinance, which is a curtailment ordinance for "pleasure burning," and will not be applicable to those with economic hardship or 100% reliance on burning as a heat source.
 - On the topic of wood smoke, Rebecca O'Neil requested Multnomah County provide upstream education on wood stoves at the time of purchase, as well as publishing articles in neighborhood newsletters. Mary Peveto suggested developing a curriculum with the City's Office of Neighborhood Involvement and sharing through neighborhood associations and meetings.

ACSI MEMBER PRESENTATIONS

• Danny Thiemann presented on farm & forestry workers.

MAKING ACSI A MORE EFFECTIVE ORGANIZATION

- John Wasiutynski shared updates from his discussion with Bradford on ways to make ACSI more effective.
- Strategies included having presentations from ACSI members on their areas of professional expertise; regularly recurring subcommittee meetings; and executive team check in meetings with JVP.

SUBCOMMITTEE REPORT OUT

- Climate and Energy
 - Catching up on a variety of projects and initiatives. **Tim Lynch** will have notes and a Doodle poll for the next meeting to take place in August.
 - Topics recently discussed, and to be focused in during future meetings, include: Housing quality and efficiency, Green and Healthy Homes Initiative, building codes, solar on affordable housing, solar plus storage resiliency projects, 100% renewables resolution and a just transition in the energy sector.
- Air Quality
 - One of the key initiatives will be to support the air quality study that will be implemented by Good Company.
 - The subcommittee has talked about an "air summit" to be held later this year, that brings several groups together to share information and prioritize efforts.
- Environmental Justice Resolution
 - Hayden Miller and Sam Baraso (Office of Sustainability) have researched how the County organizes internally, what we're currently doing on environmental justice, and what other jurisdictions have done (racial impact statements, programs, advisory boards).
 - In the coming week, Hayden Miller will reach out to internal stakeholders, and led by Commissioner Vega Pederson, a meeting will be held to define what environmental justice is, discuss what the stakeholders are currently doing, and explore possibilities for moving forward. Following this internal meeting, there will be outreach to external stakeholders.
