### REVIEW & APPROVE MEETING MINUTES

### ACSI CHAIR ELECTION

- **Ryan Vanden Brink** has been elected as the new Chair of ACSI.

### REVIEW & APPROVE ACSI LETTER TO THE BOARD OF COUNTY COMMISSIONERS

- The group reviewed the draft letter and discussed areas of consensus and areas that need improvement.
- This included the following actions:
  - **Sasha** will take the lead on making edits reflecting the group's consensus decisions. The group outlined ACSI's priorities for supporting any carbon pricing legislation, including the Clean Energy Jobs bill. Specifics included parameters around the use of revenues generated from the sale of allowances for

emissions from transportation fuels, the conveyance of free allowances, limitations on the use of offsets, and assurances that allowances are not viewed as property rights. Cumulatively, there was a consensus that any carbon pricing legislation should assure a strong cap, with a clear price signal to reduce GHG emissions in the most equitable manner feasible.

- Mary suggested a few revisions to clarify ACSI's recommendation around the wood smoke ordinance.
- Committee members suggested clarifications to the section in the letter that covers energy and health performance.
- A note of support for the upcoming EJ resolution will be added along with a recommendation to engage with the City on Portland Clean Energy Fund should the measure pass in November.

#### **DISCUSS ACSI RECRUITMENT**

- **Sam** will send an email to ACSI regarding member recruitment.
- It was noted that Mary and Ralph will be rolling off of ACSI at the end of the year
