1. Welcome (00:00:00)

Zoom Meeting Guidelines & Introductions

Oscar R. provided meeting support guidelines, including webinar setting, closed captioning, Q&A procedures, and chat feature instructions.

Commissioner Jones-Dixon led introductions of committee members and staff.

2. **Opportunity for Public Comment (00:05:18)**

No public comments were received prior to the meeting; no comments were made at the meeting.

3. Review and Adoption of February 10, 2025 Meeting Minutes - All (Action Item) (00:05:48)

Motion to adopt the minutes as presented by Councilor Todd.Seconded by Mayor Stovall. Minutes were unanimously approved.

4. Vice Chair Election - All (Action Item) (00:06:25)

Discussion regarding the need for Vice Chair elections was postponed due to potential lack of quorum in the previous meeting.

Councilor Todd expressed interest in the Vice Chair position. Motion to nominate Councilor Todd for Vice Chair was made by Tom Bouillion and seconded by Mayor Rios-Campos. Councilor Todd was unanimously elected as Vice Chair.

5. Region 1 ACT Community Member Elections - All (Action Item) (00:08:00)

(10 minutes) 3:25 pm

Sarah Paulus presented information on the Region One Area Commission on Transportation (R1 ACT) and the need to fill two community member representative vacancies (one general, one Environmental Justice).

Staff recommended Timura Ender for the Environmental Justice representative and Nancy Chapin for the general community member representative.

Motion to approve the staff recommendations for Timur Ender and Nancy Chapin.

Unanimously approved.

Action Item: Commissioner Jones-Dixon and the City of Portland's elected representative to provide letters of recommendation to R1ACT nominating Timur Ender and Nancy Chapin.

6. Fatalities Report - MaryJo Andersen, Multnomah County (00:12:38)

(5 minutes) 3:35 pm

MaryJo Andersen presented the fatalities report for January and February, noting the change in information availability due to ODOT's policy change regarding sharing victim names.

January: 6 fatalities in the metro area.

February: 14 fatalities, including 4 in East County (Gresham, Marine Drive, Fairview, and Gresham).

A moment of silence was observed to acknowledge the loss of life.

7. Transportation Safety Action Plan (TSAP) Goal Setting & Safety Analysis - Mike Sellinger and Bianca Popescu, Alta (00:16:00)

Mike Sellinger and Bianca Popescu from Alta Planning and Design provided an update on the TSAP project and an overview of the project purpose, goals, and current status.

Bianca Popescu presented additional analysis findings, including:

- a. Travel pattern equity analysis for low-income travelers.
- b. Speed data analysis comparing observed speeds to posted speed limits.
- c. Crossing safety analysis of pedestrian crashes not at crossings/intersections.
- d. Lighting analysis of pedestrian crashes after dark.
- e. Temporal crash trend analysis and focused review of two intersections: Northeast Gleason/Northeast 223rd Avenue and East Burnside Street/Southeast Stark Street/Southeast 190th Avenue.
- Discussion regarding speed data collection times (12 AM to 6 AM) and the 10-year crash data window.

Action Item: Mike Sellinger to provide the memo summarizing key crash trends, high injury corridors, equity mapping, statistically significant crash profiles, and crash trees.

Action Item: Mike Sellinger to clarify the rationale for using a 10-year vs. 5-year crash data window.

Action Item: Mike Sellinger to have engineers examine specific collision movements at the intersection of East Burnside Street/Southeast Stark Street/Southeast 190th Avenue.

Action Item: Mike Sellinger to have engineers examine the specific crash movements at the intersection of Northeast Gleason/Northeast 223rd Avenue and determine North/South/East/West collision data.

Action Item: Mike Sellinger to examine and provide data on the 5-year crash data.

Action Item: Jairo Rios-Campos requested that the team look at the correlation between population growth in East County and the rise in incidents.
