
These Indigenous communities and their cultures have resisted and survived despite the intentional and ongoing attempts to destroy them. This country was built on occupied and stolen Indigenous land.

What is the Area Plan?

- Formally called the Area Agency on Aging Area Plan
- 4 Year Plan for Older Americans Act (OAA) Programs
- The Area Plan describes how the ADVSD will provide a comprehensive and coordinated delivery system to older adults in our community
- Required by the State



What is in the Area Plan?

- Includes 6 overarching focus areas (listed on the next slide) with measurable objectives for each goal
- There is a separate service equity plan for ADVSD that will be incorporated into the upcoming area plan
- Plan includes a budget attachment for projected expenses and count of people served



Required Focus Areas

- Information and Referral Services and ADRC
- Nutrition Services
- Health Promotion
- Family and Unpaid Caregiver Support
- Legal Assistance and Elder Rights Protection Activities
- Older Native Americans

Other focus areas may be added.

- New Appendix, which is a final report on the AAA's Service Equity Plan
- Accomplishments achieved as a result of service equity efforts

Priority Communities for 2025:

- Program is ready to roll out on June 1st, 2024
- Not "open" for public yet
- Roll out in phases from June 1, 2024 March 2025
- OPIM will include the Family Caregiver Assistance for supporting unpaid caregivers
- Focus on current waitlisted and OPI consumers
- CS and partner organizations work collaboratively to plan the roll out processes



- In MultCo the OPIM eligibility will be provided by the Community Services (CS) program case managers (ECM), and the in-home services coordination and authorization will be provided by the community partner organizations' case managers (SCM)
- ADRC and community partners will be the point of contact for referrals to OPIM
- Referrals received after May 1st 2025 will be added to the OPI waitlist and reviewed for prioritization
- The State will be monitoring the program roll out and gather data

📥 2024 ASAC Meeting

- OPIM Eligibility:
 - 18-59 y.o. adults, persons with disabilities as determined by the SSA or PMDDT
 - 60 y.o. +
 - Have income up to and including 400 percent of the federal poverty level (FPL);
 - The individual's separate non-excluded resources are at or below the current monthly Medicaid nursing facility rate multiplied by six months
 - Meet the Service Priority Level (SPL) functional needs criteria within level one through 18.



- The State is working on the statewide communication about the OPIM program
- Community Services program added 2 case managers, 4 support staff and one Supervisor to manage the OPIM program. Current case manager who carries the caseload of younger (18-59 y.o.) OPI consumers will also join this team to provide eligibility determination support.
- CS is working with the State on budget projections to plan for increased consumer numbers
