do hereby grant, bargain, sell and convey unto the said grantees, as tenants by the entirety and not as tenants in community property, their heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Multnomah and State of Oregon, bounded and described as follows, to-wit:

Commencing 550 feet south of the southeast corner of the northeast 1/4 of the southwest 1/4 of the northeast 1/4 of Section 20, Township 1 South, Range 4 East of the Tillamette Meridian; thence west 360 feet to the southwest corner of parcel of land conveyed to Donald Altman by deed recorded December 11, 1947 in Book 1228, page 96, deed records, for point of beginning; thence west 100 feet; thence north to the south line of Dodge Park Boulevard; thence easterly along said south line to northwest corner of said Altman land; thence south to point of beginning, in the County of Multnomah and State of Oregon
