KNOW ALL MEN BY THESE PRESENTS, That We, Raymond M. Grattan and Selma Grattan, husband and wife in consideration of -----Ten and No/100-----, grantor :
to us paid by Donald Altman, a single man

do hereby grant, bargain, sell and convey unto the said grantees, as tenants by the entirety and not as tenants in community property, their heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Multnomah and State of Oregon, bounded and described as follows, to-wit:

Beginning 330 feet south of the southeast corner of the northeast quarter of the southwest quarter of the northeast quarter of Section 20, Township 1 South, Range 4 East of the Willamette Meridian; thence west 660 feet to a point; thence east 300 feet to the true point of beginning of the tract herein described; thence east 100 feet; thence north on a line 280 feet distant from and parallel with the east line of that tract of land conveyed to Andrew E. Johnson by deed recorded June 10, 1947 in Book 1180, page 504, Deed Records, to the south line of Dodge Park Boulevard No. 1305; thence westerly along the south line of said Dodge Park Boulevard to a point north of the true point of beginning of the tract of land herein described; thence south to the true point of beginning.

To Have and to Hold the above described and granted premises unto the said grantees as tenants by the entirety, their heirs and assigns forever.

And the grantor s... do ... covenant that we are lawfully seized in fee simple of the above granted premises free from all incumbrances,

and that we will and our heirs, executors and administrators, shall warrant and forever defend the above granted premises, and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever.
