Meeting 15 Summary

Project staff provided an update on pedestrian access for the new bridge, including connections to the Eastbank Esplanade and Gov. Tom McCall Waterfront Park. HLB Lighting Design presented the latest bridge lighting design, which reflects recent structural changes. CDAG members provided feedback on lighting elements. Project staff also shared that planning for a Centennial Celebration is underway for the bridge's 100th anniversary. CDAG members participated in a roundtable discussion to share lessons learned and future project considerations. Jon Henrichsen concluded the meeting by thanking CDAG members for their participation and commitment.

The meeting was held in-person at the Multnomah Building Boardroom from 6:00-8:00 p.m., live streamed and recorded.

SUMMARY

Brandy Steffen, JLA Public Involvement, welcomed CDAG members, thanked them for their time on the committee and provided an overview for the meeting agenda.

Megan Neill, Multnomah County, provided an update on pedestrian access from the bridge, including connections to the Eastbank Esplanade and Tom McCall Waterfront Park. The County is committed to building a new connection to the Eastbank Esplanade. Portland Parks & Recreation is leading efforts to explore a potential connection from the bridge to the waterfront park as part of the master planning process for the Gov. Tom McCall Waterfront Park Redevelopment Project. Parks Planner Marty Stockton was available to answer questions during and after the meeting. CDAG members did not have additional questions or comments.

Elizabeth Johnson, HLB Lighting Design, provided an update on bridge lighting based on recent structural changes and presented the latest design. **CDAG members** asked questions and offered feedback on several elements, including concerns regarding direct lighting views due to changes in design to the tower shape, the daylight appearance of the lighting fixtures, lighting on the bascule piers, and some members desire to add illumination of the cables.

Sarah Hurwitz, Multnomah County, shared that the Burnside Bridge turns 100 years old on May 28, 2026. Planning for a Centennial Celebration is underway and includes partnerships with local organizations to create a meaningful community event. The event date and additional details will be shared as the date approaches.

Brandy Steffen, JLA Public Involvement, facilitated roundtable remarks and collected lessons learned and considerations for the project "pick-up" plan. **CDAG members** expressed appreciation for the project team and provided several suggestions, including reconsidering or refining certain design elements, such as the changes to the tower shape, pedestrian access, vehicle capacity, operator parking on the bridge, and providing additional bridge renderings from the east side looking west. Members also shared the importance of maintaining public visibility on building an earthquake-ready structure, exploring private funding opportunities, increasing community interest and enthusiasm, and securing political champions for the bridge.

Jon Henrichsen, Multnomah County, thanked CDAG members for their participation and commitment to the project. **CDAG members** viewed a video message from Multnomah County Chair Jessica Vega Pederson expressing gratitude for their service on the project. Thank-you cards were distributed to CDAG members.

Brandy Steffen, JLA Public Involvement, made a final call for comments and adjourned the meeting.
