Meeting 9 Summary

Community Design Advisory Group members continued the conversation from the previous week to reach a bridge type recommendation. The project team answered prior questions about the Eastbank Esplanade connection and provided public comments from the online survey. The team also reviewed the group's guiding principles document. BEAM and HDR staff answered technical questions. In a unanimous decision, the group voted to remove the Unbraced Vertical Arch option from further consideration.

The meeting was held in-person in the David Evans and Associates Willamette Room from 6:00-8:00 p.m. It was live-streamed and recorded.

SUMMARY

Brandy Steffen, JLA Public Involvement, joined remotely and reviewed the agenda, safety and meeting protocols. She announced that member Sarah Lazzaro relocated outside Portland and stepped off the CDAG committee.

Megan Neill, Multnomah County, provided an update on the Eastbank Esplanade connection. The project team worked closely with the City for the last several years to find a solution but currently a ramp or elevator connection to the Eastbank Esplanade will not be part of this project. This connection could be added to the bridge as part of a future project. The project is still in conversations with the City of Portland about the future of the existing staircase.

Carol Mayer-Reed, Mayer/Reed, reminded the members of the group's guiding principles including urban/site context, user experience, visual character, and aesthetics, as they related to the remaining options.

Brenda Martin, Envirolssues, shared additional survey results, including public comments and key themes on the V-Tower and long vs. short arch options.

Brandy Steffen reminded CDAG members of the recommendation process and opened the discussion.

CDAG members continued discussing the bridge options. Members shared their preferences on the Cable Stay or Tied Arch options, emphasizing what influenced their decisions. Committee members mentioned overall project cost, maintenance, materials for the arch and the pedestrian/cyclist experience as important factors in their deliberations. The group discussed moving forward with removing one or more options from consideration.
