- Last meeting summary
  - Going slow, trying to do things different from traditional government.
     Revisiting the priority topics approach today. Original approach was priority areas, then universal goals instead, think of the universal goals as our priority areas.
  - Discuss adjusting the schedule.
  - More engagement needs to be done, tapping into existing work. Start with a survey of events, getting dates on the calendar.
  - More ownership over the deliverables.
  - Understanding specific pushback on government operations. John will be attending meetings from now on.
- Targeted universalism

  - Example from John: "everybody should have access to public buildings."
     Realized that folks using mobility devices can't access. Designed in ramps, elevators, lifts, etc. Discovered during that process that by addressing solutions for the people with greatest barrier, we're able to get closer to the universal goal for everybody. Helps parents with strollers, people with temporary disabilities, etc. Think about our collective

aspiration, and the targeted interventions that will collectively move us the furthest and fastest toward our universal goal.

- Example Universal Goal Accessing public buildings
- Impacted community & described Impacts physical barriers (wheelchair user, parents with strollers), cultural/perception ("not meant for me"/distrust of institutions)
- Potential strategy that could move us toward that goal: ADA infrastructure, culturally responsive services/staff
- Strategies can not only be physical but social and a way of belonging
- Example SUN Services has shifted to cultural responsiveness
- Desiree Eden: this is a good framework that allows for the targeted piece of who were serving in terms of making sure that \*people\* don't get left out. Excited to explore this.
- Sam G: I'm not sure I understand how the solutions are "targeted"? How
  do you get a universal solution if it's coming from a targeted place?
  - John W: if we measure ourselves against a universal goal, if we focus on the group that is further behind all the others, then all of a sudden we're much closer to the universal goal than we could if we just used a blanket approach.
- Taren: Sometimes there are multiple groups that are disadvantaged.
   Would need a variety of strategies to address all the groups that are disparately impacted.
  - JW: That is correct. We don't expect to land on one solution for each universal goal.
- Nakisha: Yep, same understanding for me, what's universal is the goal.
   The solutions are targeted, and based on understanding the barriers that exist for specific groups.
- Monique: the targeted strategies will apply in Multnomah County's jurisdiction. The universal goals will help us create multiple strategies.

#### **Discussion/Next Steps**

- Gov. staff will summarize data
- We will send out a community engagement survey what activities would you like to connect this work with - we will then follow up with you one-on-one
- Monique proposes discussing meeting schedule and objectives for next meeting
- Desiree Eden would like to continue with this work and get more granular and for gov. Staff to dig into that - what does that mean - what are the intersectionalities and impact areas - question: do we have the freedom to go back into the mural board?
