Waxyaalo ay tahay in laga ogaado gadida tubaakada iyo waxyaalaha la xiriira nikotiinta (nicotine) ee Degaanka Multnomah.

Sharcigan, waxyaalaha la xiriira tubaakada waxaa lagu qeexaa in uu yahay wixii maadooyin ah ee ka kooban, ka samaysan ama ka soo jeeda tubaakada loogu tala galay in dadku isticmaalo, kuwaasi oo ay ka mid yihiin balse aanay ku koobnayn: sigaarka caadiga ah, sigaarka waaweyn, sigaarka yaryar, tubaakada beebka, shiishada, ta sanko laga qaato buuriga, tubaakada la calaliyo 'bidis', iwm; sigaarka elektarooniga ah ama wixii waxyaalo la neefsado ka kooban ama gudbinta nikotiinta; dareeraha la nuugo, dareeraha elektarooniga ah, ama wixii dareere ah ee kale ee kama koobnn nikotiinta loogu tala galay in dadku isticmaalo. Tani kuma jiraan waxyaalaha la xiriira nikotiinta ee FDA ogolaatay ee loogu tala galay joojinta tubaakada, sida nikotiinta balastar ah ee la isku dhejiyo, xanjada ah ama 'ta la muudmuudsado'.

Tubaakada ka gad kaliya dadka da'doodu tahay 21 jir ama ka weyn tahay. Waxaad xaqiijisaa in dadka macaamiisha ah ee u muuqda in ay da'doodu ka yar tahay 30 jir aad weydiiso Aqoonsi sidoo kalena aad si taxadar leh u firiso taariikhda dhalasho.

(MCC § 21.561)

Degaanka Multnomah waxay bixin doonaan ruqsad warqad ka samaysan oo ay tahay in lagu soo bandhigo goobtaada, taasi oo ay si fudud u arki karaan macaamiishu. (MCC § 21.561)

Dhammaan goobaha kala duwan waa in soo bandhigaan calaamada loo baahan tahay (oo ay la socoto ruqsadda la bixiyay) sida uu dhigayo Sharciga Gobolka Oregon ee tilmaamaya in ay sharci darro tahay in tubaakada ama waxyaalaha la neefsado laga gado dadka ay da'doodu ka yar tahay 21 jir. (ORS 431A.175)

Baakadaynta

Waxyaalaha la Xiriira Tubaakada sida kor ku qeexan waa in la gadaa iyadoo ku jirta baakadii asalka ahayd oo ay la socdaan digniino caafimaad. Sigaarka waa in la gadaa isagoo ku jira baakado ay ku jiraan 20 xabo. Waxyaalaha la xiriira tubaakada lama furi karo si hal xabo markiiba loo gado (oo sidoo kale loo yaqaan "loosies") ama buuriga marada khafiifka ah ku duuban "snus pouches". (MCC § 21.563) (CFR § 1140.16(b)) (CFR § 1140.14(2d)) (ORS 431A.175)

Halka wax lagu Gadayo

Waxyaalaha la xiriira tubaakada oo dhan waxaad dhigtaa mafrashka dabadiisa meel ay kaliya geli karaan shaqaalaha/mulkiilayaashu ama ku rid sanduuq xiran. (ORS 167.407)

Dhiirigelinta
