Over the past four years, the district's end-of-year funds dropped from a <u>positive</u> <u>balance</u> of \$2.2 million (2021) to a <u>deficit</u> of \$219,000 (2024). The financial crisis reached a breaking point this past fall, forcing the district to take out an emergency \$2 million loan, lay off ten staff members, reduce student services, and implement furloughs to stabilize the budget.

The district needs new leadership and I have the experience and temperament to contribute. My goal is to serve the community I care deeply about and offer my skills during this challenging time for the Corbett School District.

What I bring:

- 15+ years of experience as an educator at Portland State University
- 20+ years of innovation and leadership across organizations
- Strong background in finances, budgeting, strategic planning, and community engagement
- Deep connections with teachers, staff, students, and families
- Weekly volunteer experience in my children's classrooms
- Involvement in Corbett athletics coaching with Corbett Youth Sports
