



Topic: Narrowed Bridge Width

City Comments

- Determined 17' acceptable for pedestrian and bicycle facilities
- Recommended 11' + 1' shoulder for transit and 10' for general purpose lanes
- Offered critiques and noted limitations of the modeling provided


Topic: Narrowed Bridge Width

Public Comments

- For those that supported wider bike/ped space:
 - Interest in reducing transportation emissions
- Preference for 12' lanes to accommodate freight traffic
- For those that did not support a 4-lane option:
 - Concern about having one vehicle lane in each direction if westbound transit only lane is implemented
 - If 4-lane option is chosen, preference to remove transit only lane




Traffic Configuration





Alternatives - Concept 1








