We can provide certified death certificates up to 6 months from the date for deaths that occurred in Multnomah County.

Death records can be released to immediate family members, grandparents/grandchildren, legal representatives or to persons or agencies with a personal or property right. Anyone else will need a notarized permission note from a family member. You must provide the information to prove eligibility to receive a death record. Additional documents may be required.

You must include a copy of the requestor's current photo ID.

- Photo ID can be Driver's License, Passport, Military ID, etc.

In accordance with law - ORS 432.380, access to death records is restricted for 50 years to the decedent's spouse, domestic partner who is registered by the state, child, parent, sibling, grandparent, grandchild, next of kin, legal guardian immediately before death or legal representative, an authorized representative, a person in charge of disposition, a government agency acting in the conduct of its official duties, an employee or agent of the funeral home or person acting as a funeral service practitioner who is named in the record of death or a person that demonstrates to the satisfaction of the state registrar that the certified copy is necessary for a determination related to the protection of a personal or property right of the applicant. Warning - providing false information is a felony under ORS 432.993.
