



## Coordinated Care Pathway Center

### Monthly Data Snapshot

*For the Reporting Period of Feb. 1-28, 2025*

The following includes two data sets: Cumulative data collected from **Sept. 1, 2024 to Feb. 28, 2025**, and data for the current reporting period of **Feb. 1 to Feb. 28, 2025**. Multnomah County is sharing the following schedule for future data releases. This schedule allows for a larger sample size and takes into account lags in completion data. The schedule will be as follows:

- **Monthly snapshot** with data on number of referrals by law enforcement partners into the deflection program, the number of people who were referred into the deflection program and engaged with the process<sup>1</sup>, the number of referrals made from deflection to other services and more. This report includes a lag to analyze and verify data.
- **Quarterly update** with at least a 1.5-month lag to account for 30 days to complete deflection and up to 30 days for providers to report what services were accessed (outcome, transportation, demographics, etc.). The second quarterly update will be released in mid-May 2025 and will include Jan.– Apr. 2025 data.
- **Yearly report** that will include Q4 2024-Q3 2025 data and analysis and will be released in winter 2025.

We are also working to create a public dashboard, but the monthly reports can be found [at this website](#) for the time being.

<sup>1</sup> A person is considered to have engaged with deflection if, after being brought to the Pathway Center by law enforcement, they completed the steps needed for them to receive a customized care plan with referrals to the services that can be accessed during a period of 30 days to successfully complete deflection. The steps include screenings, case management, and signing consent for the program to verify whether they completed deflection within 30 days of when they opted in to deflection.
