- Nellie: I've heard that Oregon is active in the courts fighting, but I'm hoping for the best.
- Sara: Gives overview of commissioners.
- Barb: Can you introduce the commissioners names and match them to the photo.
  - Moyer is the commissioner for ASAC/DSAC.
- Sara: Provides an overview of county boundaries and districts.
  - Forecast and overview of the County General Fund.
  - There will be roughly a 4% cut across the county, but that is an average as it will not be an even cut.
  - Now until April 24th, we will be balancing the budget. Although this is not the final budget, there will be adjustments and possible funds put back into the budget.
- Nellie: Are community partners part of the process?
- Sara: Our services are contracted out to community partners, and the chair has been meeting to hear feedback from the CBOs.
- Nellie: Is ImpactNW still functioning?
- ❖ Sara: Yes, although they might have some effect.
- ❖ Nellie: Do we still go for grants?
- Irma: We have some grant funding in CS, but it is minimal.
- Sara: Property tax revenue has dropped, affecting our budget, along with inflation, and loss of covid funding.
- Caroline: What about renovation of older buildings who handles that?
- Sara: DCA and facilities. Departments have to fund the renovation for DCA.
  - The fall forecast is a 21.2 million-dollar shortfall.
  - There is a forecast for a 21.5 million-dollar Supportive Housing Services revenue shortfall for next year (FY 2026).
- Barb: Will the slides be available to us? And are both amounts from the same pot of money?
- Sara: Yes, the slides will be available. The amounts are a coincidence. However, they come from different sources.
  - The forecasted budget does not increase over the next 5 years.
  - Our budget has to be balanced to 0.
  - We are trying to plan for the next 5 years.
  - Our priorities are rooted in partnerships, being

person-centered, creating a community where homelessness is rare, having a safety net, and having a budget that prioritizes what we need most.

- Barb: I know Safety Net is in behavioral health. Is it here, too?
- ❖ Irma: Yes, and it includes PG, Housing assistance, etc.
- Sara: The county is the last place for people to go when they are at risk of falling into poverty.
  - The best outcomes meet all of the above bullet points.
  - Are there any questions about the budget I can answer today?
- ❖ Robert: Why do I get a bill for an Art Tax?
- Sara: It is a city tax an Art Tax, Supportive Housing Tax, Preschool for All on top of property taxes. The Gas Tax is going down, and all taxes help with funding. However, the Art Tax is a city tax.

- Gail: I have been fined for the Art Tax, although I have been exempt for years.
- ❖ Barb: Two things; are we losing the name of Joint Office of Homelessness? Second question; things we are legally required to provide do we get a federal match? If so, will we lose that?
- Sara: We are trying to track that and we have some uncertainty.
- Barb: Is the BHRC okay?
- Sara: Yes, it is okay there might be reductions, although it will still function.
- Caroline: I am concerned about the safety of older buildings.
- Sara: These are important concerns and youth is a priority for Chair Pederson.
  - DCJ: has a prevention program for the youth before they enter the justice center.
  - DCHS has the sun program prevention is less mandated, but they are important to our

community.

- Robert: Youth goes into foster to avoid the justice system, but the youth can get marked for life when exiting the foster system.
- Sara: We need to provide wrap-around services when existing foster care and to remove some marks to help them get jobs and apartments, etc.

- Gail: Parks and Rec gives seniors and people with disabilities free passes and they accept silver sneakers. You can go anywhere that accepts that program.
- \* Robert: LA Fitness accepts silver sneakers.
- Caroline: That type of program would help keep seniors in their homes.
- ❖ Alex: We also have fall prevention in Community Services.
