She reviewed tasks for the council to work on, and asked discussion questions for feedback from members. - Barb. said she would like to focus on recruiting to make the group more diverse and is also interested in transportation. - Jesse said that he would like to focus on outreach for services. - Charmaine said she agrees with Barb. to expand recruitment to the BIPOC population. She does wonder if our staff reflect who we are serving and would like to see data on staff representation. We should look at community engagement and have higher levels of engagement and promote projects to a higher level. 	Sarah

	<p>Future Generations is an example of a level 3 or 4 of community engagement. She would like to be included in such a project.</p> <ul style="list-style-type: none"> - Tatyana said she would like to focus on information and referrals as a way to create an impact because it will follow from there. - Carol said she would like to collaborate with the Brain Injury Program of Oregon and transportation to medical appointments. - Tim raised concerns that the State and Oregon State Hospital disqualifies people with HIV for services. Federal cuts to Medicaid have impacted a lot of people who rely on Medicaid. OHA has stopped paying certain mental health providers. - Barb. said she and Tim can connect about some of these concerns. She also said that education about the ADRC and the needs assessment is a priority. She is happy to be a part of transportation work, although she is willing to work with other priorities. - Sarah thanked members and shared that she presented at El Programa about the councils, ADRC, etc. She shared that she will present data regarding the community needs assessment at a later date. - Jesse said that he doesn't want to overwhelm Charmaine and he wants to be involved in important outreach work. He expressed interest in a position with Multnomah County. - Sarah said DSAC notes are posted online for review. - Barb. said she would like an email with the agenda attached to it before the meetings. - Sarah thanked Barb.

<p>11:15 (20 min)</p>	<p>Safety Net Program Presentation</p> <ul style="list-style-type: none"> - Marcie provided an overview of the Safety Net program. The program has two CMs and helps with eviction prevention by providing assistance with rent, deposits, utility bills, one time assistance with supportive housing, and short-term intensive case management. Program criteria is being 60 years or older or 18-59 with SSA disability, having an income less than 200% of SSI, assets less than \$2,000, must live in Multnomah County, and must meet risk factors and have a stable plan. In FY 25 there were 694 total referrals with 523 approved referrals. 828 people served, and 793 service requests. The majority of consumers identify as white. FY 26 has helped 456 people so far and is on target for full funding and expects to serve more people than last year. The total budget is \$562,423 plus HST funding. Program staff are experts in housing and eviction, holistic assessments, etc. Partners include: district senior centers, APS, Legal Aid Services of Oregon, LTSS, Northwest Pilot Project among others. Safety Net referrals can be made through the ADRC. - Tim asked if they work with Cascade Aids Project or other culturally specific agencies. - Marcie said yes, they have worked with Cascade Aids Project, and NAYA. - Tim asked for issues with wrap-around services while working with those programs. - Marcie will follow-up with her staff and get notes to us. - Jesse said he wants the 2% of Native Americans served to 	<p>Marcie</p>

	<p>be prioritized and increased.</p> <ul style="list-style-type: none"> - Marcie agrees and they have been working on outreach with the Native community. - Tim asked about Marcie’s thoughts on the Portland city tax regarding housing subsidies. - Marcie said the Safety Net program is not funded for next year and this does not apply to the program. - Alena said she wanted to acknowledge the work of ADRC and they work directly with the people who benefit from ADRC and Safety Net services. - Barb. thanked Marcie for her work and presentation. The slides can help with advocating. Barb. explained that ADVSD has asked for a 5% reduction and this program is included in the reduction. She asked what part of the 5% this is in. - Marcie said it’s the entire program and is not sure of all the other programs included in the reduction. - Sarah said members can email questions to her if they have additional questions. - Tim asked if anyone has received services and asked if anyone knows of improvements. He also asked what programs can fill the void of Safety Net. - Alena said we need to support and assist people before they get to the point of eviction.

If a member earns \$600 or more a year they will receive a 1099 tax form. Due to privacy concerns, information will go to the Department of County Assets. Members can receive a one-time \$600 technology stipend - this will meet the \$600 for the 1099 form. Members can retain equipment or receive another one-time stipend if appointed to another term. \$65 is the monthly stipend for members. Stipends will take 30-40 days for payments. Members can pick-up gift cards in-person and will need to sign for it. If not in-person, gift 	<p>Tatyana and Sarah</p>

	<p>cards will be mailed via certified mail and members will still need to sign for it.</p> <ul style="list-style-type: none"> - Cheri gave a reminder that earned gift cards will be given at the following meeting and ACH payments will be at least 30 days after the meeting. - Barb. said that this amount is added to other totals from other councils and stipends add up for tax documents. She asked if the process will change for ACH and if there are new documents to fill out. - Cheri said no, and she will reach out if anything changes. - Barb. said she has used the \$600 and has been grateful for it. She offered to be a point of contact if needed. - Tim said he got a tablet a few days before being confirmed and is wondering if he can be reimbursed for it. - Cheri said it would need to be fully purchased - not on a payment plan. He can send a copy of an itemized receipt and she will ask if it can count for reimbursement.







Report out: DSAC Quarterly 2/24/26

The **Oregon Talking Book and Braille Library**, presented by Tiff Bowers, is part of the National Library and provides lifelong library services for anyone in Oregon with a print, visual, physical, or reading impairment who cannot read standard 12-point fonts. They offer free audio books mailed to homes with necessary equipment, as well as electronic and print braille materials and descriptive DVDs. The service currently serves 4,500 citizens across Oregon with a collection of over 150,000 books. More information is available at





ASAC/DSAC Stipend Policy Update

Payment Options & Tax Rules: Compliance with new accounting rules from the Department of County Assets.

- **Payment Methods:** Choose between **Check, Direct Deposit, or Fred Meyer Gift Card.**
- **Required Paperwork:**
 - **W-9 Form:** Required for *all* members receiving any form of payment.
 - **ACH Form:** Required only for those choosing direct deposit.
- **Tax Implications:** A **1099 federal tax form** will be issued if total annual payments reach **\$600 or more.**
- **Privacy:** Your forms are mailed directly to County Accounting to protect sensitive information.



ASAC/DSAC Stipend Policy Update

Technology Reimbursement

- **Benefit:** One-time reimbursement of up to **\$600** for devices (laptop, tablet, smartphone) or accessories (headsets, hotspots).
- **Eligibility:** Must be an appointed member and attend **3 consecutive monthly meetings** before qualifying.
- **Process:**
 - Member purchases equipment first and submits receipts.
 - Processing by County financial team takes **30–60 days** via check or direct deposit.
- **Ownership:** Members retain equipment after completing their full term (2–3 years).



ASAC/DSAC Stipend Policy Update

Monthly Participation Stipends

- **Total Monthly Eligibility:** Up to **\$65 per month** when a required council meeting is attended.
- **Breakdown:**
 - **\$30 Participation Stipend:** Covers meeting time and related work (advocacy, work groups, etc.).
 - **\$35 Digital Access Stipend:** Offsets ongoing costs like internet or phone services.
- **Note:** Stipends are not paid for additional council related activities in the same month or if a meeting is canceled by leadership.



ASAC/DSAC Stipend Policy Update

Getting Your Stipend: Timelines and physical receipt requirements.

- **Timelines:** County Finance takes 30-40 days to process payments.
 - Example: Direct Deposit or check payment for a February meeting arrives late March.
- **Gift Card Pick-up:**
 - Cards for the previous month are available for pick-up at the **next** meeting.
 - **Must sign and date** a receipt log in person.
- **Certified Mail:** If you cannot attend in person, gift cards are sent via **certified mail** and must be signed for at your home or post office.
