
### **Are Extreme Risk Laws Effective?**

A growing body of research finds that these laws can be effective at preventing gun violence when implemented effectively, particularly with respect to suicide.

- Two studies in Connecticut estimated that one suicide was averted for approximately every 11-22 gun removals carried out under the ERPO law.
- Another study found that after Connecticut increased enforcement of its ERPO law, the law was associated with a 14% reduction in the state's firearm suicide rate.
- In Indiana, in the 10 years after the state passed its ERPO law in 2005, the state's firearm suicide rate decreased by 7.5%.
- A multistate study found that one suicide was averted for every 17 ERPOs issued, which translates to 269 lives saved.

#### Findings from a study of the first 5 years:

- 60% filed by law enforcement
- 81% of respondents were male
- 84% involved a threat of assault or homicide
- 63% involved a threat of suicide
  - Half involved both assault/homicide and suicide
- 11% involved a threat of mass violence
- 35% cited domestic violence concerns
- 25% cited alcohol use/misuse as a concern
- 69% of cases where an ERPO was granted had no data on whether firearms were removed

### **Key Elements of Successful ERPO Implementation**

- Build strong cross-sector partnerships and ensure collaboration
- Provide training and support for law enforcement
- Conduct targeted outreach to key stakeholders
  - Prosecutors, judges, behavioral health professionals, crisis responders, victim advocates, community organizations
- Support for family petitioners
- Public education



### **Case Study: Broward County, FL**

#### Case Management

- ERPO cases are handled by the Threat Response Unit in Fort Lauderdale PD. Patrol officers refer potential ERPO cases to TRU, which investigates and files petitions on behalf of the department.
- A city attorney is assigned to handle the filing of all petitions and serves as the liaison and representative in court proceedings.

#### **Training**

- Basic training for all new and patrol officers on recognizing the criteria for using ERPO and identifying cases where it could be applied effectively.
- More in-depth training program for detectives in the TRU.

#### Collaboration

• FLPD collaborates closely with local social service providers, including a major behavioral health center.

### Case Study: Palm Beach County, FL

#### Case Management

- ERPO cases are primarily handled by the Palm Beach County Sheriff's Office, through the Targeted Violence Unit of the Behavioral Health Division.
- The TVU employs 15 deputies and 15 clinical therapists and specializes in identifying cases that meet the criteria for an ERPO and filing petitions.

#### **Training**

 All sworn personnel at PBSO have received training on identifying potential ERPO cases and how to refer to the TVU for an investigation.

The number of ERPO petitions dramatically increased following a new effort to train deputies.
