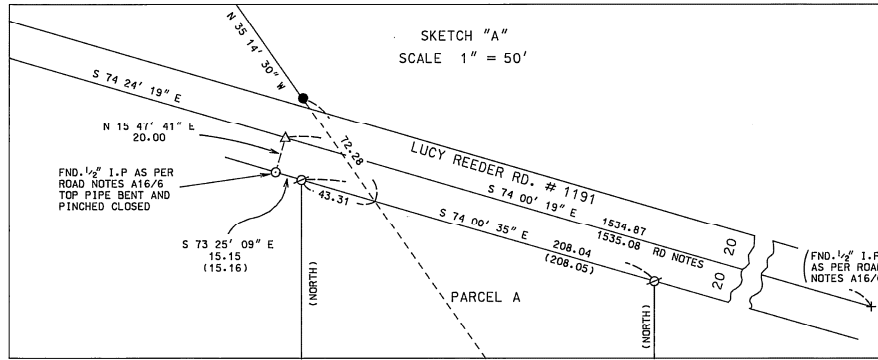

HELD TIED MONUMENTS AT THE S.E. CORNER OF THE ALEXANDER MCQUINN D.L.C. AND THE N.E. CORNER OF THE JAMES TAYLOR D.L.C. AS BASIS OF BEARINGS FOR THIS SURVEY.
