Thank you for submitting additional materials and information for your land use application on properties located at **36930 E Hist Columbia River Hwy, Corbett**. The new information has been reviewed by Land Use Planning to determine if it is sufficient to make your land use application complete. Unfortunately, the application is still incomplete because:

We did not receive all of the requested items listed in our previous letter to you dated, **February 28, 2025**. The outstanding items are listed below:

- 1. **Narrative**: Your cover letter states that you included an "amended narrative" to address Item #1. No amended narrative was included in your uploaded submission.
 - a. Please re-upload and provide a complete and detailed narrative.
- 2. **Dimensional Requirements and Development Standards Storm water/drainage control**: Your cover letter states that the storm water issues are addressed in the amended narrative. No Stormwater Drainage Control Certificate reviewed and certified by an Oregon Licensed Professional Engineer was provided. As a reminder, Multnomah County Code requires that all new impervious surfaces and or the replacing of existing impervious surfaces is required to be reviewed.
 - a. Please Stormwater Drainage Control Certificate

Please submit the **two** remaining items at your earliest convenience so that we can move forward with processing your application.

As a reminder, if you are unable to make your application complete within 180 days of the original submittal, your application will be closed, your materials returned and fees will be forfeited. The application must be made complete by **Tuesday**, **July 29**, **2025**.

Thank you for your efforts to date and I appreciate your attention to this matter. I look forward helping you move forward with this project as soon as possible.
