The Multnomah Channel is tidal and therefore a navigable water that is state-owned through the Oregon Admission Acts and Equal Footing Doctrine. The Multnomah Channel is considered part of the Willamette River and therefore subject to the Tideland Act of the 1870s. Map and tax lot 2N1W21-01200 is a portion of a land grant patented by the federal government prior to the repeal of the Tideland Act; as such, the state automatically granted the tideland to the riparian owner. The state retained the bed of the Multnomah Channel up to mean low water fronting this tax lot.

The state's ownership fronting map and tax lot 2N1W21-01200 is the bed of the Multnomah Channel up to mean low water. NOAA's VDatum estimates mean low water to be 6.34 feet elevation NAVD 88 at this location. We are not able to estimate a line on an aerial photograph.

I do not know if we can provide a response to your questions as to whether the "meander line" you reference is the same bank as the "easterly boundary in 1968. Our ownership specialist can tell me where we currently own to, but the questions you seem to be asking refer to other boundaries which DSL does not manage or track. Are you wanting to know where DSL's ownership extends to on the Multnomah Channel at this parcel, or is there another question you're getting at?

Because the Multnomah Channel is tidally influenced, ownership of the bed and banks were passed to the Oregon at statehood under the Equal Footing Doctrine. Its more than likely that the State owns to Mean High Water, but I'd have to submit to our Ownership Specialist if you need a firm determination. Is this something you need?

We are seeking information regarding the boundary of the State's ownership of Multnomah Channel. Attached is a tax lot map for Section 21, 2N1W. The unit of land in question is tax lot 1200.

The applicant's attorney is representing that the unit of land (TL 1200) in 1968 went to the meander line. Their deed states that it goes to the "easterly boundary of Multnomah Channel (also known as the Willamette Slough)".

We are seeking clarification whether the meander line would be the same bank as the "easterly boundary" in 1968?

What year did the State obtain ownership of the Multnomah Channel? Was it at Statehood or was there a later navigability test? If later, what year?

Thank you for your assistance in this matter. We have a deadline for submission to the hearings officer of this information this Friday, October 22nd at noon.
