- Established Emergency Operations Center
- Fill Incident Management Team roles
- Developed Mission Statement, Incident Objectives, and Command Emphasis
- Several collaborative briefings completed to quickly identify gaps, needs, and opportunities
 - Health Officer Division, Corrections Health, Behavioral Health Division, Joint Office of Homeless Services, Health Officers, health Department Director's Office, Integrated Clinical Services, Public Health Division, law enforcement, Portland Fire and Rescue, overdose coordination, outreach and navigation
- Established reporting parameters and cadence



Focus for week 3:

- Regular Situation Status reports twice weekly
- Hone data needs which will lead to policy development and dashboards
- Identify additional topics for additional Unified Command briefings (substance use disorder providers, Department of Community Justice, Sheriff's Office, and more)
