This worksheet provides necessary information for a floating structure placement or relocation within a moorage/marina application. Complete each section below. Use one worksheet for each proposed placement or relocation.

Complete the Applicant section of this form and provide the following:

- ☐ Site Plan of the moorage/marina where the new or relocated floating structure will be moored. The plan should show the location of the riverbank and illustrate all floating walkways, gangway-ramp(s), boat slips, or berths, and the location and type of structure proposed to be moved or built. Highlight the slip that will be filled.
- ☐ Photos of the existing structure proposed to be relocated or architectural drawings or plans of the new or expanded floating structure. Indicate overall dimensions of the floating structure (length, width, and height), describe the exterior materials, lighting, and colors, and indicate the type of floating used
- ☐ Photos of All Exterior Lights on Building & Property
