### CBAC Budget Feedback

Our role as a committee is to review Non-Departmental program offers and provide input to influence budgetary decisions according to the diverse perspectives and needs of communities within Multnomah County. We envision a County that is accountable, collaborates with other jurisdictions, protects our environment, provides for the safety of the public and advances equity – especially for Black, Indigenous and other communities of color, as we know these communities are disproportionately impacted by County budget decisions.



### CBAC Budget Feedback

Our CBAC established the following priorities for FY22:

- Advance equity
- Address houselessness and the housing crisis
- Promote emergency preparedness
- Serve mental health, addiction and behavioral needs
- Reduce contribution to climate change and build climate resilience

Our program implementation priorities are ensuring accountability (monitoring program efficacy, efficiency, and inclusivity), and promoting collaboration across jurisdictions and with external County service partners. We suggest all County offices engage with Reimagine Oregon and listen, collaborate and commit to appropriate progressive action in order to create meaningful and sustainable change.

- Ages 16-78





# OCI FY22 Budget - \$326,430






### Stipends for Committee Members
