- 1. This order supersedes and replaces SO 011.23 Booking Criteria for Multnomah County Detention Center.
- 2. As the Sheriff's Office continues to evaluate booking criteria, the following offenses will be bookable:
  - a. Any felony or misdemeanor offense codified in the Oregon Revised Statutes.
  - b. 14A.50.150 Camping Prohibited When Reasonable Alternate Shelter is Available.
  - c. 14A.50.160 Restrictions on Camping on Public Property and Public Rights-of-Way.

The Multnomah County Jail population has surpassed 90%. Due to the unanticipated extended court closure caused by the inclement weather, the Multnomah County Sheriff's Office has employed measures to control the jail population; as such, only the following specified offenses are permitted to be booked into Multnomah County custody until such time as this order is rescinded.

The "bookable offenses" list shall be limited as follows:

- 1. Any Class A, B, and C felonies;
- 2. Any "Person Class A Misdemeanor" as set forth in OAR 213-003-0001(15);
- 3. Any offense subject to mandatory arrest under Oregon law;
- 4. Any warrant arrest.

MCSO Deputies and members of our partnering agencies shall not book any individual charged with an offense that is not specified above.
