01/13/26 Meeting Discussion Notes:

- Michelle Davis - knows of a potential youth who might be good for JJSC.
ACTION: Michelle - Email Kyla and cc: Tiona about a potential youth candidate for JJSC.
- Kate Molina was the vice chair of JJSC. Kate left her position in November; therefore, we need to appoint a new vice chair.

- Vice chair duties: co-facilitating and agenda planning
 - Marcell recommended someone from a community-based organization serve in that role, for balance purposes.
 - Kamille and Ximena volunteered to be co-vice chairs.
 - **ACTION:** Tiona - schedule JJSC agenda planning meetings for Kamille, Ximena and Kyla.

- Kamille - POIC has a step-by-step guide/handbook that answers these questions. **ACTION:** Kamille - share a copy of the parent handbook that outlines court procedures.
 - POIC/LatinoNetwork shares this with parents and alternates being present at preliminary hearings.
- DCJ research team to present JJIS data about youth in Multnomah County
- Marcell - is willing to present on 2025 data for Gresham youth violence, since the trends in Gresham differ from those in Portland.
- Updates
 - LatinoNetwork -
 - Many of the families they serve are not going to work/meeting in person. Many groups have shifted online.
 - There has been a need to train staff how to respond if incidents happen during their home visits. LatinoNetwork has been more diligent around their facility, since it is a target for ICE. They have legal observers on site.
 - Teenagers are taking on more of the responsibilities in order to protect their parents (ie getting gas, buying groceries, baby sitting).
 - Donald E Long Detention/Court
 - Many parents are afraid of visiting youth in the facility. The facility is offering online visiting options.
 - Some parents are afraid to go to attend court hearings. Gunnar shared he has seen the option to call in is being used more.
 - There has been an increase in gang activity. Training has been offered to staff on de-escalating this type of conflict. There is concern these conflicts will continue as they are released back into the community.
 - ODHS has a mobile van - they are looking into leveraging that to service clients (exp. distributing food boxes) who are afraid to visit ODHS offices.
- There are plans for Rockwood for high density housing. High density housing tends to be less expensive, attracting lower-income families as well as undocumented families. High density increases risk of altercations.

Even if offering to help with relocation, many families cannot afford to live anywhere else.

- Rep. Maxine Dexter has secured \$1 million for E Multnomah County for Gang Intervention. Commissioner Jones-Dixon has also been supportive in getting funding.
- POIC has partnered with Albina Project to relocate families back to N and NE.
