Area Plan Results:

- 2,410 responses
- After filtering for criteria, our final sample is 1,808 respondents
 Filtering Criteria:
 - Multnomah County zip + zip codes in 30-mile radius
 - Aged 50+, or
 - Aged 18-49 with a disability, someone who served in the military, is a caregiver, identifies as Native American or Alaska Native, identifies as an immigrant or refugee, LGBTQ+, or unhoused/homeless
- Question (Anne): Why are we including people who live outside of Multnomah County in the survey? - they may not be eligible for services.
- Response (Jason & Alex): Does not recall the details on why exactly 30 miles was decided for the criteria, however the intention is to collect caregiver responses and they may live within a 30 mile radius.
- Question (Barb): what is different between this survey and the last survey?
- Response (Alex & Jason): In comparison to the last survey, we have more respondents to this survey - attributing to council involvement, paper surveys, staff support, gift cards, and advertising. Overall, an increase in participation.
- Response (Kristin Riley): All of their consumers were given the opportunity to take the survey as well as the rest of the residents we have direct contact with.
- Question (Dave): Participation from Asian Health Services Center might be an example of over sampling as opposed to reaching a new population and others who are not familiar with County services.
- The survey has 13 language responses, although English is the majority, followed by Simplified Chinese, Spanish, etc.
- Age: 65-74 years old are the majority of respondents, followed by age: 75-84, 55-59, etc.
- Race and Ethnicity: The majority of respondents are White, followed by: Asian, Native American and Alaska Native, Black and African American, Hispanic and Latino/a/e/x, Prefer to Self-describe, Middle Eastern/North African, Native Hawaiian and Pacific Islander.
- Gender: Majority of respondents identify as women, followed by men, and Non-Binary.
- Question (Anne): Gender respondents: Are women over reported, or are men under reported, compared to the Multnomah County general population.
- Response: (Jason & Alex): Waiting for the PSU report in January.
- Sex: 67% of respondents are Female, 32.8% are Male, and 0.2% have identified as being

Intersex.

- 53.6% report not having a disability, and 46.4% of respondents identify as having a disability.
- Feedback (Charmiane): Readability was super high college level, and respondents struggled with the ability to read the survey. A 5th grade reading level would have been helpful.
- Follow up (Nicole Galport): We will keep this in mind for the future, and reading support is okay.

Listening Sessions Update:

- After feedback from previous meetings, we are considering sessions at: Asian Health Services, Somali Community Partners, a possible Native American focus group, and an online option that will be open for the public for those who could not attend in-person.
- We would like to provide refreshments (culturally specific), a gift card raffle, Trimet passes, and translators.
- We are also considering conducting the listening sessions during an already occurring meeting time, and providing paper feedback forms.
- Feedback (Anne): After the results from PSU we might adjust our approach to reach other communities who might be less represented. Additional listening sessions might be needed to reach more communities.
- Feedback (Caroline): There is an African IRCO that might be a good one to reach out to.
- Feedback (Barb): It might be nice to offer full day trimet passes, and it would be beneficial to have a hybrid session.
- Response (Alex): It's hard to offer that with 4 different listening sessions due to translation and technology availability at the location of the listening session.
- Marina hopes if at all possible, they will all be hybrid.
- Response (Barb & Charmiane): There is great technology and multiple laptops can be used for each location and the use of headphones.
- Question (Caroline): Asked if outreach has been done with cultural centers, religious centers, health centers? We had a massive list.
- Response (Alex): That goes out to health partners in hopes that they can.
- Feedback (Caroline): MIRACLES Club is a great place to get to African Americans for input

 this is a recovery center, also Brain Injury Alliance of Oregon is a great place to reach
 out to.

- Response (Lars): On Dec 13th the budget office will receive all info for the upcoming year. It will go into detailed depth about all things budget.
- Question (Barb): So, Irma and her people have a meet and greet with our new commissioners?
- Response (Alex): There are some meetings where they do all get together, and they are closed door.
- Response (Charmaine): On the Thursday meetings, each director will present their budget.
- Question (Jesse): Do we have Native Americans on the board for CBAC?
- Response (Alex): Brought up demographics and it shows that we do.
- Response (Charmaine): There is a Native American liaison in the county. There is also a Native American resource group. They are much more represented than 10 years ago.
- CBAC is the Community Budget Advisory Committee and each department is required to have one.
