


To meet the criteria, the candidate must serve as their own treasurer, not have an existing candidate committee, and not expect to spend or receive more than \$750 during the entire calendar year (including in-kind contributions and personal funds).</p> <p>If you have an existing candidate committee you must amend the statement of organization not later than 10 days after a change in information. This includes changes to the election you are active in and the office you are running for.</p> <p>See the Campaign Finance Manual for the procedural and legal requirements of establishing and maintaining a candidate committee.</p>
