**What you need to do:** Call/email to make an appointment for a specific time and date.

**What you must bring:** Marriage license, certificate & at least two witnesses (18 years and older)

Fees: ORS 106.120(4)(a) requires the payment of a \$117 fee to the Multnomah County Circuit Court for all marriages performed in the courthouse. This fee must be paid prior to the wedding. Please ask where to pay this fee when scheduling the wedding. In addition to the \$117 fee, there is a \$100 fee payable to the Judge for weddings outside of regular court hours (5pm or after).
