THE REASONS GIVEN FOR DEMANDING THE RECALL OF GORDON FULKS, AS FILED IN THE RECALL PETITION:

“Members of the Corbett community and Water District customers seek the recall of Gordon Fulks for the following reasons:

- 1) Unethical behavior towards employees of the district, fellow board members and members of the Corbett community.
- 2) Violating his fiduciary responsibility to the community and its customers, of honesty, trustworthiness and disclosure.
- 3) Making monetary and budgetary decisions for the district without following adopted Water District Board Policy and by violating Public Meetings protocol.”
