I grew up in East Multnomah County and I have a deep love for this community. In 2001 my family moved to Fairview, and in 2006 I began volunteering on Fairview's Planning Commission. I have also served on the budget committee and volunteered in other areas of the city as well. During this time, I have been impressed with how well the city is run, but I see potential for growth.

I believe Fairview can grow into a community where people want to live and that offers a high quality of life. I believe that as a city we are at a crossroads, if we work together, and make the right decisions, we can see Fairview grow and improve into an even better community than it is.

One of the things that concerns me is the direction of Fairview's financial situation. When I was on budget committee we worked hard to create a balanced budget while keeping our reserves intact. Since then the city's reserve fund has been steadily decreasing, I understand we need to use reserves at times, but this steady decrease is concerning. To help increase the city's revenue, we can encourage development and new business. In September, I proposed a plan to City Council that has the potential to increase business in Fairview. If revenue increases, other amenities can be added to Fairview (for example, a skate park or an off leash dog park, things that benefit the whole community). It's time for a City Council that is up front, transparent in their actions and willing to work hard to make Fairview a better place to live.
