

#### Letter to the Voter

**Dear Multnomah County Voter:** This is your Voters' Pamphlet for the May 20, 2025 Special District Election. This pamphlet is mailed to all residential households in Multnomah County and includes information about candidates and measures from local special districts within the boundaries of the County. Local elections are important. Please take into consideration the following information to make your vote count in this election.

The registration deadline is **Tuesday, April 29, 2025**. You can view your registration status and update if necessary at OregonVotes.gov/MyVote.

- Urban Flood Safety and Water Quality District: This is the first regular election of directors for this district. To implement staggered terms, the directors elected in May will draw lots after the election to determine which two positions will be on the ballot in May 2027 and which three positions will be on the ballot in May 2029.
- Six official drop sites have been impacted by library construction closures this election. These include: Albina, Belmont, Kenton, Rockwood, St. Johns and Woodstock libraries. If you frequent one of these library locations, please view our Official Ballot Drop Site Location Change Information page for more details on how to return your ballot at one of our new official ballot box locations. Please contact us if you need assistance casting your ballot.
- For a list of official ballot drop sites in Multnomah County, please visit our website: MultCo.us/DropSites

Ballots will be mailed to registered voters on Wednesday, April 30, 2025. If you do not receive your ballot by Thursday, May 8, 2025, please call 503-988-VOTE (8683) or email elections@multco.us.

To be counted, voted ballots must be received at any County elections office in Oregon or Official Ballot Drop Site location by 8:00 p.m., Tuesday, May 20, 2025, or postmarked by Tuesday, May 20, 2025.

In addition, ahead of the election we are asking voters to **Let's Make a Plan to VOTE!** Here is what you can do to be ready for the election and ensure your vote is counted:

- 1. Register to VOTE. Update your voter registration information or register to vote at OregonVotes.gov/MyVote. The Voter Registration Deadline is April 29. Sign up to Track Your Ballot at Multco.us/TrackYourBallot.
- 2. Get your ballot. You will receive your ballot in the mail beginning April 30. If you have not received your ballot by May 8, take action and contact the elections office.
- **3. VOTE your ballot.** Remember to sign your ballot return envelope. Your signature is your identification. If you forget to sign or your signature does not match we will contact you so you can take action and we can count your vote.
- **4. Return your ballot.** Two ways to return your ballot **1) Return by mail**, your ballot envelope must be postmarked by Tuesday, May 20 and received within seven days to be counted. **2) Official Drop Site**, voted ballots must be received at any County elections office in Oregon or official drop site location by 8:00 p.m., Tuesday, May 20.
- **5. Have a VOICE and make a difference.** Unofficial election results will be posted after 8:00 p.m., May 20 at MultnomahVotes.gov. Final official election results are certified by June 16, 2025.

# **Election Definitions**

Special district elections happen on the third Tuesday in May of odd years. The election on Tuesday, May 20, 2025 is a Special District Election used to elect board members to special districts, such as school boards, water, or fire districts.

#### **Community College District**

Community colleges, sometimes called junior colleges, are two-year schools that provide postsecondary education. In Oregon, each community college has an elected Community College Board that sets policy for the college. The board oversees the development of programs and services, the adoption of policies and budget, to meet the needs of the college district.

#### **Education Service District**

An Education Service District (ESD) is a regional education agency. ESDs work to provide the various school districts with a wide array of educational programs and services, many of which are too costly or limited in demand for a single location. Multnomah Education Service District is an educational cooperative that provides a wide variety of programs and services on a regional basis to school districts in Multnomah County and beyond. An elected board governs Multnomah ESD. Five members are chosen by zone (area in which they live), and two are selected from the county at-large.

#### **Water District**

A water district is a regional water service provider organized under Chapter 264 of the Oregon Revised Statutes. The water district provides drinking water to residents of the district. Each water district board is composed of five board commissioners elected by voters. The board is responsible for developing policies and procedures and a budget.

#### **Fire District**

Rural Fire Protection Districts are fire protection service districts organized under Chapter 478 of the Oregon Revised Statutes. Rural Fire Protection District provides fire suppression and emergency medical service to residents of the district. Each Rural Fire Protection District is composed of five board members elected by voters. The board is responsible for developing policies and procedures and a budget.

#### **Soil and Water Conservation District**

The Soil and Water Conservation District (SWCD) Program provides services to the 45 Soil and Water Conservation Districts throughout Oregon. These services include technical support and limited administrative oversight, with the intent of reducing both liability and risk to the SWCDs and the Oregon Department of Agriculture.

#### **School District**

School districts are charged with the administration of public schools. Typically, a school district includes grade schools, middle or junior high schools, and high schools that are governed by a School District Board. School district boards in Oregon comprise seven elected board members by district or by zone. Some board members must reside or are elected by zone and some are elected at-large by voters in the school district.

#### **Term/Unexpired Term**

Board members serve a four-year term. If a vacancy occurs on the Board, an election may be held to fill the remaining 2-year unexpired term.

# **Facts to Know about Voting and Elections**

#### Who can register to vote in Oregon?

- You must be a United States citizen,
- A resident of Oregon,
- And at least 16 years old. You will get your first ballot in the mail once you are at least 18 years old. You must register to vote at least 21 days before Election Day.

#### How can I register to vote?

- Online at oregonvotes.gov/register or
- On a paper Oregon Voter Registration Card that can be picked up at an elections office, DMV, public library, or post office.


#### How does vote by mail work?

All elections in Oregon are conducted by the county elections office. The elections office mails ballots directly to voters. Voters complete their ballots, and then return them to the county elections office in the mail or by putting them into an Official Ballot Drop Box.

#### Vote by mail in a few simple steps:


- 1) Register to Vote
- 2) Receive a Voter Notification Card
- 3) Receive a Voters' Pamphlet
- 4) Receive Your Ballot
- 5) Vote Your Ballot
- 6) Return Your Ballot

#### How do I vote my ballot?




Find the candidate or measure response (YES or NO) of your choice. Completely darken the oval to the left of your choice with blue or black ink. Do not use felt tip markers.

#### **Write-In Votes**



To vote for a write-in candidate who does not appear on the ballot, completely darken the oval to the left of the line provided for the office and write the full name of the candidate on that line.

- Make sure you have correctly marked your choice for each contest.
- · Your official ballot may have contests printed on both sides.
- Place the ballot in the return identification envelope. Read the Voter's Statement on the return envelope and sign in the signature box.
- Your ballot cannot be counted if you do not sign the return envelope.
- Every signature is checked against the registration signature on file. The signatures must
  match for the ballot to be counted. If you vote for more candidates than allowed for an
  office or if you vote both Yes and No on a measure, it is called an overvote and your vote
  will not count for that contest. If you make a mistake or change your mind while marking
  your ballot,
- You may correct it yourself. See example below.
- Make your choice obvious so that your intent is understood and your vote is counted correctly.



 If you are unable to correct your ballot, you may request a replacement ballot from the elections office.

Almost eight years ago, I was first elected to the Mt Hood Community College Board of Trustees. Since that time, thanks to the hard work of the board, the college administration, and dedicated employees in a range of positions, our college has seen numerous successes. Our new Strategic Plan involved the broader community. Our board and President have been recognized both at the state level and nationally for leadership, as well as for our support of students. Last fall the college received the Government Finance Officer's Association award for financial excellence, and we have become the first community college in Oregon to offer a Bachelor of Applied Science degree in Cyber Security. # What are tips for flood preparedness?

- 3. Make an emergency plan: Map your evacuation route and emergency contacts
- 4. **Protect important documents:** Store IDs, insurance papers, and financial records in a waterproof container or have digital copies
- 5. Have emergency supplies ready to go: Prioritize water for drinking, a first aid kit with prescription medications, a flashlight, important documents (see above), and cash

If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.

**SUMMARY:** Measure authorizes up to \$1.83 billion in principal amount of general obligation bonds for facilities and education investments.

If approved, this measure would finance capital costs, including:

# **Update, Repair Aging Elementary and Middle Schools:**

• Update/replace major building systems, including roofs, siding, heating/cooling

#### Make Schools Safe and Secure:

- Update safety, security systems
- Seismic upgrades

# Modernize, Improve Educational Materials, Technology and Schools:

- Renovate/replace schools, including Cleveland, Ida B. Wells (formerly Wilson)
- Upgrade curriculum materials, technology, including student devices

# **Increase Extracurricular Opportunities:**

- Upgrade/expand high school athletic facilities; create district-wide athletic hubs at Jackson,
   Marshall
- Update high school performing arts/theater facilities

Requires community accountability/oversight; independent audits of projects and expenditures

Bonds may be issued in one or more series, each series maturing in 30 years or less.

Due to declining debt service, measure is not expected to increase PPS's bond tax rate above \$2.50/\$1,000 assessed value, the rate that has been targeted since 2017 bond. Actual rates may differ based on interest rates and changes in assessed value.

#### **EXPLANATORY STATEMENT**

If approved, this measure will allow Portland Public Schools to continue to prioritize schools in need of large-scale repairs and replacements to address safety hazards and to fix failing infrastructure.

This measure is not expected to increase tax rates above the level targeted by the 2017 bond. In 2012, 2017, and 2020, voters approved capital bonds that funded improvements to many of Portland Public Schools's aging buildings, creating modern, safer places for students to learn.

Since 2012, the bond program has fully modernized eight schools, with three more under design. In addition, the bond program has addressed some of the infrastructure needs at every school throughout the District.

#### Prior investments include:

- Roosevelt, McDaniel, Franklin, Grant, Benson, and Lincoln High Schools, Kellogg Middle School, Faubion PK-8, and the Multiple Pathways to Graduation building were fully modernized.
- Full modernizations of Jefferson, Ida B. Wells, and Cleveland High Schools are in design.
- Health and safety improvements, including:
  - Replacing plumbing to reduce lead and improve water quality;
  - Removing or encapsulating exposed lead paint and asbestos;

- Upgrading fire alarm and sprinkler systems;
- Repairing or replacing leaking or deteriorating roofs;
- Mitigating radon exposure;
- Strengthening school safety and security.
- Educational improvements, including:
  - Upgrading science labs;
  - Enhancing technology;
  - New curriculum materials.
- Accessibility improvements for children and adults with disabilities.

# What Would the Proposed 2025 Bond Fund?

If approved, bond funding would address additional building, health, safety, and learning needs in schools across the District, while continuing PPS's plan to comprehensively address facility needs by improving all of our schools over the long term.

If approved, the bond funds will:

# **Update and Repair Aging Elementary and Middle Schools:**

• Update or replace leaking or deteriorating school roofs, mechanical systems (heating and cooling), and other building repairs

#### Make Schools Safe and Secure:

- Update safety and security systems including additional cameras, fencing to protect students and staff
- Seismic upgrades

# Modernize, Improve Educational Materials, Technology, Schools:

- Renovate/replace Cleveland and Ida B. Wells (formerly Wilson) High Schools
- Utilize any high school improvement cost savings to update/repair elementary and middle schools
- Provide comprehensive, culturally relevant, and current curriculum materials across core and supplemental subject areas
- Replace or provide student tablets and laptops to provide equitable access to classroom learning, and update classroom and District technology

#### **Increase Extracurricular Opportunities:**

- Upgrade athletic facilities, including needed improvements for Roosevelt, Lincoln, Franklin and Grant and create athletic hub facilities at Jackson Middle School and Marshall campus.
- Update high school performing arts/theater facilities.

#### **What Would the Bonds Cost?**

Because the tax rate on existing bonds is scheduled to decline, PPS's bond tax rate is not expected to exceed the previous estimate of \$2.50 per \$1,000 of assessed value. The total principal amount of bonds authorized by this measure cannot exceed \$1.83 billion.

# **Oversight and Accountability**

An independent group of community members will review quarterly reports and audits of how the bond dollars are being spent to provide accountability to the public until construction is completed.

Julia Brim-Edwards, 2/4/25 Board meeting, 2:41: "I've been involved with six PPS bonds. This is the bond with the least amount of public comment, the least information, and **no community stakeholder group.** We can't keep shutting down discussion."

Patte Sullivan, 12/2/24 Board meeting, 1:20: "Technology and curriculum updates should be paid for **out of the general fund, not a construction bond.**"

# **Ballot Title**

# **Continue Five-Year Local Option Levy for Scappoose Fire District**

**Question:** Shall Scappoose Fire District continue a \$1.99 per \$1,000 levy for another five years to fund essential medical/fire operations? This measure renews current local option taxes.

**Summary:** The proposed measure seeks to continue a levy of \$1.99 per \$1,000 of assessed property value for the Scappoose Fire District, funding essential operating expenses from 2027 to 2031. This revenue is critical for several key services, including the continuous staffing of two ambulances 24/7 including the medications and equipment that supports response operations. The funding will ensure compliance with NFPA medical testing for firefighters. Levy funds are also used to fulfill federal and OSHA personal protective equipment testing requirements and replacement. Funds will be used for annual safety inspections and maintenance for the four fire stations. Levy funds are also used to maintain NFPA and federal compliance for emergency vehicles maintenance and replacement when needed. Projected revenue from the levy is estimated to be \$3,381,674 in 2027, \$3,483,125 in 2028, \$3,587,618 in 2029, \$3,695,247 in 2030 and \$3,920,287 in 2031, ensuring essential resources for community safety. The estimated tax cost is based on data from the county assessor and considers potential early payment discounts, compression, and collection rates.

#### **EXPLANATORY STATEMENT**

The proposed funding measure is essential for maintaining and enhancing the comprehensive emergency services provided by our fire district. This measure addresses several pressing issues our emergency response agencies face, ensuring that we can continue delivering effective care and support to residents.

Our fire district offers a wide range of services, including structure fire response, wildfire response, marine firefighting (serving 16 marinas), advanced life support ambulance services, community paramedic program, water rescue, and rope rescue. Additionally, we engage in community risk reduction activities, which encompass fire and life safety business inspections, fire extinguisher training for the community, emergency response planning and training. We also conduct reviews of sprinkler, fire alarm, and fire and life safety plans, and we provide educational STEM and college classes at the local high school, as well as fire safety education programs for schools.

Data shows that our emergency response system faces significant demands, with average monthly call volumes indicating that multiple emergency calls occur simultaneously 50% of the time. This high call volume reinforces the necessity of maintaining two ambulances available 24 hours a day, ensuring a prompt response to emergencies, regardless of when they occur.

Presently, ambulance billing revenue is declining, with our collection rate from Medicare and Medicaid averaging around 40%. This shortfall places a financial strain on our ability to provide critical services and procure the necessary medications and equipment to support our response operations. Securing the proposed funding will stabilize our finances and ensure that our emergency medical teams have the resources needed for high-quality care.

Moreover, the funding is vital for compliance with National Fire Protection Association (NFPA) medical testing requirements for firefighters. Adhering to these standards enhances

the safety and effectiveness of our personnel, ensuring we meet rigorous expectations for emergency responders.

The levy funds will also help fulfill federal and Occupational Safety and Health Administration (OSHA) personal protective equipment testing requirements. Regular testing and replacement of equipment are essential to protect our firefighters and maintain their readiness to respond safely and effectively.

Additionally, a portion of the funding will support annual safety inspections and maintenance for our four fire stations. Well-maintained facilities are crucial for operational efficiency and for providing a safe working environment for our emergency personnel.

Another vital aspect of the funding will be the maintenance and replacement of emergency vehicles in compliance with NFPA and federal standards. Ensuring that our emergency vehicles are in optimal condition is crucial for the safety of our responders and for the timely and effective delivery of services to our community.

In summary, the proposed measure is crucial for maintaining current operations and meeting the heightened demands for emergency services. It will provide the necessary funding to ensure adequate ambulance availability, support compliance with critical safety standards, fund vital equipment repairs and replacements, and maintain our facilities. By approving this measure, residents will help ensure our community receives the emergency care it deserves, safeguarding the health and safety of all citizens.
