I have conducted audits of the County's human services contracting processes, public guardian services, protective services for developmentally disabled clients, the cost and administration of capital construction processes, business practices used in the delivery of mental health care, and the library system's expansion and cost. I have also audited various services in the eight school districts within Multnomah County as part of the accountability efforts stipulated in the temporary income tax passed in 2003. Included in these projects were audits of teacher leave practices, transportation services, personal services contracting, and intra-district student transfers.

I am a Certified Internal Auditor and a Certified Government Auditing Professional. I was appointed the designee for the Multnomah County Auditor in January 2003.
