Introductions, Announcements, and Approval of Minutes

Introductions were made.

The October LPSCC minutes were approved.

Later in the meeting, Chair Kafoury announced LPSCC has two open positions: Community Representative and Victims Services Representative. The LPSCC website has more information.

Opioid Rapid Response Project

Samantha Byers, Opioid Rapid Response Project Coordinator of the Oregon Health Authority, presented on the implementation of House Bill 4143, the Legislature's recent effort to tackle the Opioid epidemic. For an overview, implementation success and challenges, pilot project details, and funding & partnerships, see the presentation.

Dr. Paul Lewis noted the following:

- In Oregon, white people have highest rate of opiate use, but Native Americans followed by African Americans have the highest rates of overdose deaths.
- Deaths are 5-15% higher for re-entry populations.
- Options for medical treatment include a shot that blocks opiates, methadone, and suboxone.

Questions and points of discussion from members and attendees included:

- What is the capacity for linking people into community-based treatment? Answer: There is capacity for outpatient treatment, but limited capacity if housing is needed.
- Sheriff Mike Reese talked about community-based non-profits wanting to leverage what they are doing.
- There was discussion about involving peers in the planning process. Sheriff Reese talked about a plan
 to involve peer navigators at booking. Lakeesha Dumas had ideas about intervening post-release. Peer
 involvement will be critical.
- There was discussion about how this pilot can be applied to all substances.

Parent Partnership Handbook

Annette Majekodumni and Justice Rajez with POIC Community Healing Initiative (CHI) presented information about the process of creating the Parent Handbook for Justice Involved Youth. The handbook is now printed in both English and Spanish. An invitation to the handbook launch celebration was given.

The following points were highlighted:

- Many parents have their own trauma and negative experience with systems.
- Inclusion and authentic relationships are key.
- The process was parent-led and expert-supported.
- Ask the impacted.
- The handbook will be shared electronically.

Legislative Session

With the Legislative Session approaching, time was given for agencies to share issues/priorities they are working on for the 2019 session. The following was highlighted:

Multnomah County:

- More funding for mental health and expanding successful programs like STP
- More funding for supportive housing and services
- Support for changing non-unanimous jury verdicts

Multnomah County Sheriff's Office (MCSO):

- Removing barriers for Medical Assisted Treatment in overdoses
- MCSO publishes legislative priorities in January

Oregon Justice Department (OJD):

- Chief Justice Walters has developed her priorities that include:
 - Restore court funding that has been cut
 - Additional programs and judicial positions
 - Funding to complete courthouses

Multnomah County District Attorney (MCDA):

- UUV (stolen vehicles) legislative fix
- Cost of Crime--take a wider look at impacts/cost of crimes to society as a whole, not just systems
- Justice Reinvestment funding
- Losing dependency funding will decrease the number dependency cases.

Public Defenders

- Compensation
- Unanimous juries

- Pretrial reform
- Restricting death penalty
- Eliminate cash bail

Dept. of Community Justice

- Baseline funding. Time study should be recognized and community supervision funded accordingly.
- Measure 57 and JRI funding
- Domestic Violence funding

DCJ Juvenile Services Division

- Reforming Measure 11
- Expungement reform
- Detention facility guidelines
