### Introductions, Announcements, and Approval of Minutes

Introductions were made. The February minutes were approved.

Multnomah County Sheriff's Office (MCSO) Chief Deputy Nicole Morrisey announced 36 individuals were released from jail over the weekend through emergency population release.

The jail is still at 94 percent capacity. MCSO is working to implement brief jail mental health screening and communications/training for jail staff.

### Community Representative Recognition

Long-time community representative Judy Hadley shared her history with the criminal justice system. Abbey Stamp presented Judy with a plaque and thanked her for decades of serving. LPSCC is now recruiting two new community representatives.

### Juvenile Services Division Detention Reform Update

Deena Corso, Dept of Community Justice Juvenile Services Division Director, presented an update from the fall 2017 presentation on detention use and reform. Areas of focus were the use of pre-adjudication detention, length of stay in pre-adjudication, and racial and ethnic disparities in detention. Drivers and next steps were discussed. There was discussion around racial and ethnic disparities. This may be a future LPSCC topic.

### Community Healing Initiative (CHI) Early Intervention Evaluation

Dr. Brian Renauer gave the background for the CHI EI program, which began in 2015 after a review of disparities in juvenile justice system. The voluntary program's goals are to reduce

overall disparity in referrals to Juvenile Services Division (JSD) among youth of color and reduce the likelihood that youth in the program return to the juvenile justice system.

The outcomes report found that CHI-EI is a worthy substitution for the prior warning letter approach and lowers recidivism overall and for each major racial/ethnic.
